**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Vehicular Homicide - Operate Motor Vehicle in Grossly Negligent Manner**

Minnesota Statute: 609.2112.1(a)(1), with reference to: 609.2112.1(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 05/15/2022

Control #(ICR#): 22016921

Charge Description: That on or about 5/15/2022, at the intersection of County Road 81 and Brooklyn Boulevard in the City of Brooklyn Park in Hennepin County, Minnesota, ADAM HUNTER PATTISHALL, did by operating a motor vehicle in a grossly negligent manner, cause the death of D.J.F.

**COUNT II**

**Charge: Criminal Vehicular Operation - Great Bodily Harm - Gross Negligence**

Minnesota Statute: 609.2113.1(1), with reference to: 609.2113.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 05/15/2022

Control #(ICR#): 22016921

Charge Description: That on or about 5/15/2022, at the intersection of County Road 81 and Brooklyn Boulevard in the City of Brooklyn Park in Hennepin County, Minnesota, ADAM HUNTER PATTISHALL did, by operating a motor vehicle in a grossly negligent manner, cause great bodily harm to C.M.F.

**COUNT III**

**Charge: Drugs - 3rd Degree - Possess 10 grams or more a narcotic drug other than heroin**

Minnesota Statute: 152.023.2(a)(1), with reference to: 609.101.3, 152.023.3(a)

Maximum Sentence: 20 YEARS AND/OR \$75,000-\$250,000

Offense Level: Felony

Offense Date (on or about): 05/15/2022

Control #(ICR#): 22016921

Charge Description: That on one or more occasions within a 90-day period, 5/15/2022, near the intersection of County Road 81 and Brooklyn Boulevard in the City of Brooklyn Park in Hennepin County, Minnesota, ADAM HUNTER PATTISHALL unlawfully possessed one or more mixtures of a total weight of 10 grams or more containing a narcotic drug other than heroin, to-wit: methamphetamine.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about May 15, 2022 at approximately 7:18 a.m., an officer from the Osseo Police Department observed a grey Chevrolet Impala with an obstructed license plate parked at a business at 401 County Road 81 in the City of Osseo. As the officer approached the Impala, another vehicle parked in an adjacent parking bay, a white Chevrolet Silverado, accelerated out of the parking lot at a high rate of speed. The officer did not activate the squad car's emergency lights or attempt to stop the Silverado, but noted it had some type of lettering on the side and a white male in the driver's seat with no other occupant visible. The vehicle ran a stop sign and proceeded southbound on County Highway 81.

At the intersection of County Road 81 and Brooklyn Boulevard in the City of Brooklyn Park, Hennepin County, Minnesota, which is approximately 1.3 miles south-southwest of where the white Chevrolet Silverado was initially observed, the white Chevrolet Silverado struck a red Kia Sportage from behind. D.J.F., a known adult male, was found in the driver's seat of the red Kia Sportage and was determined to be deceased at the scene from apparent injuries sustained in the collision. C.M.F., a known adult female, was in the front passenger seat of the red Kia Sportage. C.M.F. was transported to the hospital for treatment of her injuries. At the time of the writing of this complaint, C.M.F. is in critical condition, has several emergency surgeries, and has been diagnosed with a brain bleed and a fractured back.

The red Kia Sportage came to rest in the center of the above intersection and the white Chevrolet Silverado came to rest in the grass on the side of Highway 81. Several eyewitnesses indicated they observed the red Kia Sportage stopped at a red light at the above intersection when the white Chevrolet Silverado approached from behind and struck it. An eyewitness in a vehicle next to the red Kia Sportage estimated the white Chevrolet Silverado was traveling over 70 miles per hour. The speed limit in that area is 45 miles per hour. Another witness indicated she did not see brake lights illuminated on the white Chevrolet Silverado as it struck the other vehicle.

Several witnesses described seeing a white male wearing a reflective high-visibility vest with a white long-sleeved shirt underneath and white pants run from the white Chevrolet Silverado toward several nearby businesses. Officers observed ADAM HUNTER PATTISHALL, DOB 1/28/2000, Defendant herein, exiting a nearby gas station. Defendant is a white male and had what appeared to be fresh blood on his clothing and hand. Officers learned that Defendant was seen entering the women's restroom of the gas station and exiting with different clothing. A long-sleeved white sweatshirt and Chevrolet key fob were found in the women's bathroom, and a reflective vest was found on the ground nearby.

In a search of Defendant's person incident to arrest, officers located 12.6 grams of a clear crystalline substance that field tested as positive for both methamphetamine and fentanyl. Defendant claimed to have ingested heroin prior to arrest. A search warrant for a sample of Defendant's blood was obtained and DNA and toxicology test results are pending.

Officers determined that the white Chevrolet Silverado truck driven by Defendant had been stolen in a burglary of a business that occurred in the early morning hours of May 15, 2022, which remains under investigation.

Defendant is in custody.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
