The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence: 15 YEARS AND/OR \$30,000

Offense Level: Felony

Offense Date (on or about): 01/30/2022

Control #(ICR#): 22000918

Charge Description: That on or about 1/30/2022, in Hennepin County, Minnesota, Cody Robert Jarosz possessed ammunition or a firearm and Cody Robert Jarosz has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, May 14, 2015, in Court File 27-CR-15-947 where Defendant was convicted of First-Degree Aggravated Robbery, for which the sentence or court supervision expired on or after August 1, 1993.

COUNT II

Charge: Theft-Take/Drive Motor Vehicle-No Owner Consent

Minnesota Statute: 609.52.2(a)(17), with reference to: 609.52.3(3)(d)(v)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 01/30/2022

Charge Description: That on or about 1/30/2022, in Hennepin County, Minnesota, Cody Robert Jarosz took and/or drove a motor vehicle, a 2005 Chevrolet Silverado, without the consent of (owner's name) or the owner's authorized agent, and he/she knew or had reason to know that the owner or authorized agent did not give consent, and the motor vehicle had a value of less than One Thousand Dollars (\$1,000.00) and the property stolen is a motor vehicle.

COUNT III

Charge: Receiving Stolen Property

Minnesota Statute: 609.53.1, with reference to: 609.52.3(1)

Maximum Sentence: 20 YEARS AND/OR \$100,000

Offense Level: Felony

Offense Date (on or about): 01/30/2022

Charge Description: That on or about 1/30/2022, in Hennepin County, Minnesota, Cody Robert Jarosz received, possessed, transferred, bought or concealed stolen property or property obtained by robbery, and Cody Robert Jarosz knew or had reason to know the property was stolen or obtained by robbery, and the property was a firearm.

COUNT IV

Charge: Fleeing a Peace Officer in a Motor Vehicle

Minnesota Statute: 609.487.3, with reference to: 609.487.3 Maximum Sentence: 3 YEARS AND 1 DAY AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 01/30/2022

Charge Description: That on or about 1/30/2022, in Hennepin County, Minnesota, Cody Robert Jarosz did by means of a motor vehicle, flee or attempt to flee from a peace officer acting in the lawful discharge of an official duty, who Cody Robert Jarosz knew or reasonably should have known was a peace officer.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about January 30, 2022, Bloomington police responded to a call involving a suspicious vehicle on the 6500 block of Cecilia Circle for a suspicious vehicle call. The reporting party indicated that the vehicle was not supposed to be there and the address where it was siting had recently been victims of thefts and burglaries.

Police arrived on scene and observed one person in the vehicle in the driver's seat. This person was later identified as CODY ROBERT JAROSZ (DOB 02/10/1992), "Defendant" herein. Police blocked the vehicle in and Defendant began to shift the vehicle into drive and began ramming squad vehicles. The vehicle fled police and police chased it. Police attempted to quickly perform a PIT on the vehicle but Defendant was able to evade those attempts. Defendant got onto Interstate 494 and went eastbound and ran over stop sticks at about Pilot Knob Road. Defendant exited Interstate 494 at Dodd Road and police were able to successfully perform a PIT on Defendant at that time that caused Defendant to go into a adjacent ditch. At this time, law enforcement observed Defendant possess a handgun, later identified as a .22 caliber Ruger firearm. Police were able to successfully arrest Defendant and detain him. On Defendant's person police found .22 caliber ammunition and found suspected narcotics on Defendant as well.

The .22 caliber Ruger firearm was located on the driver's seat with a spare loaded magazine along with drug paraphernalia and some phones. The .22 caliber Ruger had a serial number of 22297666.

The vehicle, a 2005 Chevrolet Silverado, Defendant was driving was confirmed stolen out Brooklyn Park from a dealership. The firearm that was found appeared to match a firearm that was stolen in a burglary in Isanti County where Defendant is a suspect.

Defendant also had keys for multiple vehicles and items that belonged to another person. There were also license plates in the vehicle.

Defendant is prohibited from possession weapons due to a conviction on May 14, 2015, in Court File 27-CR-15-947 where Defendant was convicted of First-Degree Aggravated Robbery.

Defend currently has a pending Prohibited Person in Possession charge in Hennepin County that is pending. Defendant also has pending charges in Hennepin County for burglary and fleeing police in a motor vehicle.

Defendant did not have permission to be in possession of the vehicle.

In post-Miranda statements, Defendant admitted to stealing the truck out of Brooklyn Park. Admitted to doing the burglary in Isanti County where the Ruger .22 caliber was stolen from and admitted to fleeing police because he was scared and it was out of instinct. Defendant did admit to knowing he was fleeing from police.

At this time, Defendant is currently in custody. Due to Defendant's behavior and the fact he is pending felonies when he committed this offense, the State is requesting higher bail for Defendant as Defendant has shown he will not remain law abiding. Defendant is also a suspect in numerous ongoing investigations.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
