**COMPLAINT**

Summons

Amended

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Fleeing a Peace Officer in a Motor Vehicle**

Minnesota Statute: 609.487.3, with reference to: 609.487.3  
Maximum Sentence: 3 YEARS AND 1 DAY AND/OR \$5,000  
Offense Level: Felony

Offense Date (on or about): 01/24/2022

Control #(ICR#): 22000321

Charge Description: That on or about 1/24/2022, in Hennepin County, Minnesota, TYLER ROBERT KLINE did by means of a motor vehicle, flee or attempt to flee from a peace officer acting in the lawful discharge of an official duty, who TYLER ROBERT KLINE knew or reasonably should have known was a peace officer.

**COUNT II**

**Charge: Traffic - DWI - Operate Motor Vehicle Under Influence of Alcohol**

Minnesota Statute: 169A.20.1(1), with reference to: 169A.20.3, 609.101.4, 169A.26.2, 169A.26.1(a)  
Maximum Sentence: 365 DAYS AND/OR \$900-\$3,000  
Offense Level: Gross Misdemeanor

Charge Description: That on or about 1/24/2022, in Hennepin County, Minnesota, TYLER ROBERT KLINE drove, operated, and/or was in physical control of a motor vehicle while under the influence of alcohol, and there was an aggravating factor present.

**COUNT III**

**Charge: Traffic - DWI - Operate Motor Vehicle - Alcohol Concentration 0.08 Within 2 Hours**

Minnesota Statute: 169A.20.1(5), with reference to: 169A.20.3, 609.101.4, 169A.26.2, 169A.26.1(a)

Maximum Sentence: 365 DAYS AND/OR \$900-\$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/24/2022

Control #(ICR#): 22000321

Charge Description: That on or about 1/24/2022, in Hennepin County, Minnesota, TYLER ROBERT KLINE drove, operated, and/or was in physical control of a motor vehicle while having an alcohol concentration at the time or as measured within two hours of the time of driving of 0.08 or more, and there was an aggravating factor present.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

COMPLAINT AMENDMENT: THE DEFENDANT'S ADDRESS IS UPDATED. DEFENDANT IS NO LONGER IN CUSTODY AFTER POSTING BOND.

On or about January 24, 2022, at approximately 12:36 a.m., law enforcement officers responded to an accident caused by a driver going the wrong way near northbound Highway 100 at Brooklyn Boulevard in Hennepin County, Minnesota. Officers learned that the vehicle, a gray Dodge Grand Caravan with Minnesota license plate 843-XHJ, drove away from the accident and continued to travel southbound in the northbound lanes of traffic.

A Crystal police officer then saw the vehicle re-entering Highway 100 going southbound in the northbound exit lane to France Ave North. The officer activated the emergency lights of his patrol vehicle and attempted to block the vehicle from entering the highway. The driver, Defendant TYLER ROBERT KLINE (D.O.B. 11/17/1983), made eye contact with the officer, drove around the squad car, and fled.

Defendant drove southbound in the northbound lanes of Highway 100. A Crystal Police Sergeant then attempted a maneuver using his squad car on the vehicle as it exited Highway 100 at County Road 81, still going the wrong way. Defendant continued to flee, and a second maneuver was performed. Officers were eventually able to stop Defendant by driving a squad car into Defendant's vehicle.

Defendant refused several commands to exit the vehicle and was physically taken out of the driver's seat. He smelled strongly of a consumed alcoholic beverage, had watery, bloodshot eyes, and had poor balance. Defendant was placed in custody.

Defendant was transported to the New Hope Police Department where he was read the Minnesota Implied Consent Advisory. Defendant stated he understood the Advisory and agreed to provide a sample of his breath for testing which revealed a blood alcohol concentration of 0.20 at 1:22 a.m.

Defendant remains in custody.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
