## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

In January 2022, investigators with multiple police agencies in the Twin Cities area began investigating a string of carjackings, robberies, and thefts that were linked by time, video, modus operandi, and circumstance to two suspects – KASHAWN JASON WERTMAN, DEFENDANT WERTMAN herein, and NAUTICA ALAJA ARGUE, DEFENDANT ARGUE herein. These offenses occurred between January 7, 2022 and January 17, 2022 when the two were arrested after fleeing police in a stolen motor vehicle. The offenses impacted communities in Saint Louis Park, Plymouth, Richfield, Brooklyn Center, Minneapolis, Edina, White Bear lake, Roseville, Columbia Heights, Lakeville, Eagan, Little Canada, Burnsville, Woodbury, and Saint Paul. The investigation into these offenses is ongoing and additional charges are anticipated in Hennepin and nearby counties.

On January 7, 2022 at 12:10 p.m., Saint Louis Park Police officers responded to a theft of a motor vehicle from a driveway located on the 1400 block of Jersey Avenue in Saint Louis Park, Hennepin County Minnesota. Officers responded and spoke with Victim A, a known adult female. Victim A reported that she was warming her vehicle, a silver Toyota Rav 4, in her driveway and stepped back into her house momentarily. She stated that when she looked out of her window, she saw her vehicle being driven away down the street.

Shortly thereafter on January 7, 2022 at 1:30 p.m., White Bear Lake Police officers responded to a carjacking on the 1800 block of Birch Street in White Bear Lake, Ramsey County, Minnesota. Officers responded and spoke with Victim B, a known adult male. Victim B told officers that he was delivering food to a customer at this address. Victim B recounted that as he returned to his vehicle, an individual approached and pointed a gun at him through the individual's jacket. The individual then grabbed Victim B's keys and stole his white Jeep Grand Cherokee. A witness observed this incident and was able to provide the license plate of the vehicle that dropped the individual off in the area seconds before the robbery occurred. That vehicle was Victim A's stolen silver Toyota Rav 4. The witness also saw Victim A and Victim B's vehicles leave the area in tandem following the robbery. Victim B's white Jeep Grand Cherokee was used by Defendants in several robberies and carjackings on January 9, 2022

On January 9, 2022 at 6:29 a.m., Roseville Police officers located Victim A's stolen Toyota Rav 4 in the parking lot of a motel. Video from the hotel depicted two individuals getting out to the stolen vehicle, entering the hotel, and going to a room that was rented using Defendant Wertman's grandmother's credit card. A search of the Rav 4 revealed identifying stolen property from Victim B.

On January 9, 2022 at 3:35 p.m., Plymouth Police officers were dispatched to a middle school located on the 12000 block of Ridgemount Avenue in Plymouth, Hennepin County, Minnesota on the report of a carjacking. Officers responded and spoke with Victim C, a known adult female. Victim C told officers that she was at the school attending her child's basketball game when she went to her vehicle to retrieve a water bottle. As she walked back towards the school, Defendant Wertman approached her and demanded her keys. Defendant Wertman forcibly grabbed Victim's C's keys from her hands. Defendant Wertman then entered Victim C's black Xfinity QX5 and drove off. Surveillance video captured this incident and showed Defendant Wertman being dropped off at the school by someone driving Victim B's stolen white Jeep Grand Cherokee. The surveillance also showed Defendant Wertman's face and distinctive clothing which included ripped blue jeans with a bright green spray-painted strip down the outside leg. A review of Defendant Wertman's Facebook page revealed photographs of him wearing those same jeans January 14 and 17, 2022. Victim C's vehicle was recovered from a parking lot in Burnsville where Defendant

Wertman's girlfriend resides later this same day.

On January 9, 2022 at 6:55 p.m., Ramsey County Sheriff's deputies were dispatched to a grocery store located on the 2300 block of Rice Street in Little Canada, Ramsey County, Minnesota on the report of a theft. Officers responded and spoke with Victim D, a known adult female. Victim D reported she was walking in the parking lot of the grocery store when a white SUV approached her. Victim D stated that the front seat passenger in the vehicle reached out and ripped her purse off of her arm inflicting pain before fleeing the area. Victim D described the thief as matching the description of Defendant Argue. Victim's purse contained her credit cards and checkbook.

Shortly thereafter at approximately 7:00 p.m., at a nearby shopping center in Roseville, officers responded to two reports of a white Jeep Grand Cherokee assaulting and stealing items from two individuals. Officers spoke with Victim E who reported that when she left the mall, two individuals approached her, said they would kill her, pushed her to the ground, and attempted to steal her purse. When Victim E started calling 911 from her watch, the suspects fled. Minutes later, Victim F reported that she was walking to her vehicle with a cart and was followed by a suspect who matched the description of Defendant Argue. Victim F reported that she was shoved to the ground by Defendant Argue who also stole her purse with her cell phone. Surveillance video captured a white Jeep Grand Cherokee as the vehicle associated with these incidents. Victim F's phone pinged to the same apartment complex associated with Defendant Wertman's girlfriend resides and where Victim C's vehicle was recovered.

Shortly thereafter at approximately 8:00 p.m., Victim D learned that her credit card was attempted to be used at a gas station located in Lakeville, Dakota County, Minnesota. Surveillance video from the gas station shows Defendant Argue arrive in Victim B's stolen white Jeep Grand Cherokee and depicts her face inside the gas station store where the credit card was used.

On January 10, 2022 at 11:11 a.m., Saint Louis Park Police officers were dispatched to a parking ramp located on the 1600 block of Duke Drive in Saint Louis Park, Hennepin County, Minnesota on the report of a carjacking. Officers responded and spoke with Victim G, a known adult female. Victim G told officers that she was walking to her vehicle when she heard a man with a mask run up behind her and rip her purse from her arm. The man demanded her keys. When Victim G said she didn't have her keys (because the keys were in the purse already taken), the man shoved her to the ground causing her to hit her head and elbow on the pavement. The man then fled with Victim G's black Range Rover. Surveillance video captured Victim G's vehicle leaving the area, following in tandem behind a white Jeep Grand Cherokee. License plate reader information detected that Victim G's stolen vehicle was driven by a location just over a half mile from Defendant Wertman's residence in Saint Paul, Minnesota. Victim G's stolen vehicle was recovered on January 18, 2022 in Eagan, Minnesota. Inside the Land Rover was a receipt from January 10, 2022 at 5:14 p.m. for a restaurant located only a few blocks from Defendant Argue's residence in Saint Paul, Minnesota.

Victim B's stolen white Jeep Grand Cherokee that was used in these preceding offenses was recovered by law enforcement on January 11, 2022 at 8:30 p.m. at the same apartment complex where Defendant Wertman's girlfriend resides, where Victim C's vehicle was recovered, and Victim F's stolen phone pinged.

On January 12, 2022 at 10:09 a.m., Richfield Police officers responded to two robberies occurring in the same parking lot on the 7500 block of Lyndale Avenue South in Richfield, Hennepin County, Minnesota. Officers responded and spoke with Victim H, a known adult female. Victim H told officers that she was visiting a patient at this location. When she parked her 2010 red Chevrolet Traverse in the lot, she was approached by two individuals matching the descriptions of Defendants Wertman and Argue. Victim H recounted that Defendants had their hands in their pockets as if they were holding guns. They told Victim H that she had five seconds to hand over her keys. In fear, Victim H handed over her keys and the Defendants

got into her vehicle and left the area.

A second officer on this call was flagged down by Victim I, a known adult female. Victim I told officers that she was just confronted by two individuals matching the descriptions of Defendants Wertman and Argue. Victim I recounted that Defendants demanded her keys and tried to steal her dogs that she was walking. Victim I was able to hold onto her keys and dogs and Defendants ran to the other side of the parking lot when the dogs started to bark. Victim I watched as Defendants then approached Victim H, demanded her keys telling her that they had a gun, and stole her red Chevy Traverse.

Shortly thereafter on January 12, 2022 at 1:45 p.m., Brooklyn Center Police officers were dispatched to a gym located on the 1500 block of Shingle Creek Crossing in Brooklyn Center, Hennepin County, Minnesota on the report of an attempted carjacking. Officers responded and spoke with Victim J, a known adult female. Victim reported that she had just arrived at the gym for a workout in her Porsche Cayenne. She recounted that a red vehicle pulled up next to her and the occupants yelled for her to give over her keys or she would be shot. The driver of the vehicle, determined to be Defendant Wertman, got out of the car and started yanking on Victim J's arm to get the keys. When Victim J resisted, Defendant Wertman punched her in the face, causing her to fall to the ground, and her lip to swell. Victim J was able to write down the license plate of the red vehicle as it fled the area, which matched Victim H's vehicle that had just been stolen out of Richfield.

Also on January 12, 2022 at 4:09 p.m., Edina Police officers were dispatched to a daycare located on the 7700 block of Computer Avenue in Edina, Hennepin County, Minnesota on the report of an attempted carjacking. Officers responded and spoke with Victim K, a known adult female. Victim K reported that was picking up her child from daycare when a red SUV pulled up next to her. She was approached by two individuals subsequently identified as Defendants. Defendants told her repeatedly to give over her keys to her Audi Q5. She relented out of fear and was able to grab her purse and phone from her vehicle. Defendants then demanded her purse and Victim K ran towards the door to the daycare. Victim K fell to the ground and Defendant Argue got on top of her. The owner of the daycare came out to intervene pulling Defendant Argue off Victim K. Defendants got back into the red SUV and fled. Victim K and the daycare owner were able to snap pictures of the vehicle, which matched Victim H's vehicle that had just been stolen and used in another robbery.

Also on January 12, 2022 at 4:49 p.m., Saint Louis Park Police officers were dispatched to an address located on the 1400 block of Dakota Avenue South in Saint Louis Park, Hennepin County, Minnesota on the report of a carjacking. Officers responded and spoke with Victim L, a known adult female. Victim L told officers that she was walking out to her vehicle when two individuals subsequently identified as Defendants approached her. Victim L recounted that one of the defendants told her to give over her keys saying that she had 10 seconds. When Victim L held onto her keys that Defendants were pulling on, one of the Defendants punched her in the head and her key fob broke away from her keychain that she was holding onto. Defendants then got into her 2018 gray Nissan Rogue and left the lot. Defendants left behind Victim H's stolen red Chevy Traverse which was recovered by law enforcement at the scene. On January 14, 2022, Defendant Argue posted a photograph of herself and Defendant Wertman inside of Victim L's stolen Nissan Rogue. Victim L was able to identify the unique personal property in her vehicle that was also visible in the photograph.

On January 15, 2022 at 1:12 p.m., Saint Louis Park Police officers were dispatched to an address located on the 2700 block of Louisiana Avenue S in Saint Louis Park, Hennepin County, Minnesota. Officers responded and spoke with Victim M, a known adult female. Victim M told officers that she was making a delivery as part of her job to a resident at the apartment complex. When she returned to her car, she was approached by two individuals subsequently identified as Defendants. Victim M recounted that both Defendants had their hands in their pockets and appeared to have guns. One of the defendants said to

give over her keys or they will shoot. One of the defendants pulled Victim M's keys from her pocket. One 1/2022 defendant got into Victim M's black Nissan Rogue and the other got into Victim L's silver Nissan Rogue. Both fled in tandem. Victim M was able to snap a picture of Victim L's vehicle that was used in this robbery. This robbery was captured on surveillance video and shows Defendant Argue wearing a distinctive grey jacket that she is seen wearing in her Facebook photos and other surveillance video related to these robberies. Defendant Wertman is also depicted wearing similar clothing to other robberies. The video shows both Defendants reaching into Victim M's pockets and Defendant Wertman twice striking Victim M's arm to try and get the property from her before Defendant Argue is seen getting into Victim M's vehicle and leaving the scene at the same time that the silver Nissan Rogue leaves the lot. Victim M's vehicle was located severely damaged and abandoned in Minneapolis on January 16, 2022.

On January 16, 2022 at 3:18 p.m., Saint Louis Park Police officers were dispatched to a gym located on the 5200 block of Cedar Lake North in Saint Louis Park, Hennepin County, Minnesota on the report of a carjacking. Officers responded and spoke with Victim N, a known adult female. Victim N reported that she had just parked in the parking ramp when an individual, subsequently identified by admission as Defendant Wertman, approached her and demanded her keys. When Victim N did not immediately comply, Defendant Wertman elbowed her in the chest causing pain and ripped the keys from her hand. Defendant Wertman then drove her Audi TT out of the parking lot.

On January 17, 2022 at 4:37 p.m., Saint Louis Park Police officers were dispatched to a residence located on the 1600 block of Duke Drive in Saint Louis Park, Hennepin County, Minnesota on the report of a robbery. Officers responded and spoke with Victim O, a known adult female. Victim O reported that she had just gotten out of her vehicle when two individuals, subsequently identified as Defendants, approached her. Victim O reported that one of the Defendants put their hands on her shoulders and asked for her purse. Victim O stated that she tried to distract Defendants by throwing money at them. As Victim O tried to get away, her phone was stolen. Defendants fled in silver sedan. Victim O's stolen phone was recovered from Victim N's silver Audi when recovered by police with Defendants inside.

On January 17, 2022, Minneapolis Police officers were dispatched to the area of the 700 block of 9th Street SE in Minneapolis, Hennepin County, Minnesota on the report of a carjacking. Officers responded and spoke with Victims P and Q, known adult females. Victims P and Q told officers that they had just parked their tan Subaru when a silver sports car pulled up next to them. Two individuals, subsequently identified as Defendants, approached Victim P and grabbed her purse by wrapping their arms around her. Defendants then ran away – one fleeing in Victim N's Audi and the other in Victim P's Subaru. The Subaru crashed into another vehicle nearby resulting in one of the defendants getting back into the Audi which fled. Portions of this incident are captured on surveillance video.

On January 18, 2022, Ramsey County Sheriff's deputies went to an address located on the 1700 block of Maryland Avenue in Saint Paul, Ramsey County, Minnesota looking for Defendant Wertman in connection with these crimes. Upon leaving the residence, officers encountered Victim N's stolen Audi being driven by Defendant Wertman with Defendant Argue in the passenger seat. Officers activated their emergency lights in an attempt to stop Defendants. Instead, Defendant Wertman accelerated away at a high rate of speed extinguishing the vehicle's lights. Assisting officers on the street with lights activated and others monitoring cameras followed Defendant Wertman as he fled from police into Cedar Riverside neighborhood of Minneapolis, Hennepin County, Minnesota and then back into Saint Paul to the address where officers were looking for Defendant Wertman. Defendants were taken into custody in that residence. At the time of arrest, Defendant Argue had a key fob for a Nissan vehicle in her jacket.

Defendant Wertman was advised of his rights pursuant to Miranda and stated that he was arrested driving a stolen Audi. He initially stated that he got the vehicle from a friend and didn't know it was stolen. He eventually admitted that he stole the Audi related to Victim N but denied any other robberies or thefts. He

denied that he had been in Saint Louis Park any time recently and claimed not to know where Saint Louis Park was located. Defendant Wertman also admitted that the fled from police but let police catch him because he wanted to see his son. Defendant Wertman told the officers that they should be out arresting murders, not people who steal cars.

Defendant Argue was advised of her rights pursuant to Miranda and stated that she was in Saint Louis Park on January 14, 2022 with Defendant Wertman. She admitted that she was in a photo on her Facebook page with Defendant Wertman on January 14, 2022 and said she didn't know whose vehicle that was.

Forensic analyses of the recovered stolen vehicles and both Defendants' phones are in process.

During the course of this investigation, law enforcement located a photograph that Defendant Wertman posted on Facebook holding a firearm with an extended magazine. The photograph was posted on January 14, 2022.

Defendant Wertman has two juvenile adjudications for Aggravated Robbery in the First Degree (27-JV-21-849, 62-JV-21-332) and Assault in the Second Degree (62-JV-21-270) for which he is presently on probation supervision. He also has a pending felony charge for Prohibited Person in Possession of a Firearm.


