COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Conduct - 1st Degree - Penetration or Contact under 14 - Actor > 36m older

Minnesota Statute: 609.342.1a(e), with reference to: 609.101.2, 609.342.2(b), 609.342.2(a), 609.3455.10, 609.342.2(c)

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 12/01/2021

Control #(ICR#): 22042435

Charge Description: That on or about 12/27/2021, at a residence in Hennepin County, Minnesota, AZZEL MICKEY LEE FOSTER, born 05/08/1992, engaged in sexual penetration with Victim 1, a person under fourteen (14) years of age at the time of the act, and more than thirty-six months younger than AZZEL MICKEY LEE FOSTER.

COUNT II

Charge: Criminal Sexual Conduct - 2nd Degree - Contact under 14 - Actor > 36m older

Minnesota Statute: 609.343.1a(e), with reference to: 609.101.2, 609.343.2(a), 609.3455.10

Maximum Sentence: 25 YEARS AND/OR \$10,500-\$35,000

Offense Level: Felony

Offense Date (on or about): 12/01/2021

Control #(ICR#): 22042435

Charge Description: That on or about 12/27/2021, at a residence in the City of Minneapolis in Hennepin County, Minnesota, AZZEL MICKEY LEE FOSTER, born 05/08/1992 engaged in sexual contact with Victim 2, a person under fourteen (14) years of age at the time of the contact, and AZZEL MICKEY LEE FOSTER was more than 36 months older than victim.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

In February of 2022, Minneapolis Police received a report of child sexual abuse. In a subsequent interview at CornerHouse, Victim 1, a known 9 year old female child, reported that an individual she identified as "Ace," who was subsequently identified as AZZEL MICKEY LEE FOSTER, DOB 5/8/1992, Defendant, had sexually abused her. During the interview, Victim 1 stated that there were several instances of abuse and that Defendant had used his penis to penetrate her vagina and anus. She stated the abuse took place in her bedroom at a known residence in the City of Minneapolis, Hennepin County, Minnesota in December 2021 and January 2022.

Victim 2, a known 12-year-old male child and Victim 1's brother was also interviewed at CornerHouse. During the forensic interview, Victim 2 stated that he witnessed some of the incidents of Defendant's abuse of Victim 1 in Victim 1's bedroom. Victim 2 also stated that Defendant put his hand inside Victim 2's pajamas and underwear and touched Victim 2's penis while in Victim 2's bedroom at the same Minneapolis residence.

Defendant was convicted of 2nd Degree Criminal Sexual Conduct on May 25, 2017 in case 56-CR-16-2981 and sentenced to 90 months commitment to the Minnesota Department of Corrections.

Complainant is aware that Defendant is currently listed as a wanted fugitive by the Minnesota Department of Corrections and his location is unknown. A warrant complaint is requested.

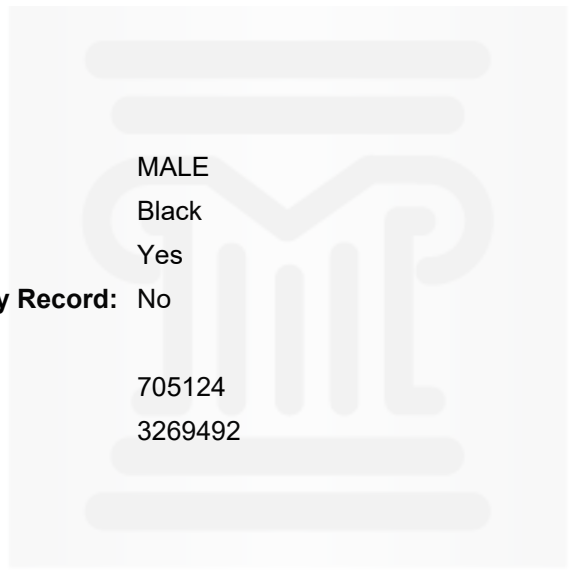
