The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Conduct - 1st Degree - Penetration - Armed w/Dangerous Weapon

Minnesota Statute: 609.342.1(b), with reference to: 609.101.2, 609.342.2(b), 609.342.2(a), 609.3455.10,

609.342.2(c)

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 01/14/2022

Control #(ICR#): 22009289

Charge Description: That on or about 1/14/2022, in Hennepin County, Minnesota, Carl Stanley Williams, engaged in sexual penetration with Victim, and Carl Stanley Williams, while armed with a dangerous weapon or any article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon, used or threatened to use the weapon or article to cause the victim to submit, to wit: held the Victim at gunpoint.

COUNT II

Charge: Kidnapping-To Facilitate Felony or Flight

Maximum Sentence: 40 YEARS AND/OR \$50,000

Charge Description: That on or about 1/14/2022, in Hennepin County, Minnesota, Carl Stanley Williams removed Victim from one place to another without her consent, in order to facilitate commission of a felony or flight thereafter, and Victim was not released in a safe place.

COUNT III

Charge: Aggravated Robbery-1st Degree

Minnesota Statute: 609.245.1, with reference to: 609.245.1

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 01/14/2022

Control #(ICR#): 22009289

Charge Description: That on or about 1/14/2022, in Hennepin County, Minnesota, Carl Stanley Williams, took personal property from the person or in the presence of Victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim to overcome her resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, while using an article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon.

STATEMENT OF PROBABLE CAUSE

Your Complainant is an Investigator with the Minneapolis Police Department, and in that capacity has investigated the facts and circumstances of the offense alleged herein, and believes the following establishes probable cause:

On January 14, 2022, a known adult female, Victim herein, reported to police that she was carjacked and abducted from a BP gas station located at 2000 Third Avenue South, Minneapolis, Hennepin County, Minnesota. Victim stated that she had just finished putting gas in her car, when she was approached by a man wearing a three-hole ski mask later identified as CARL STANLEY WILLIAMS, Defendant herein, who pointed a handgun at her and told her to get in her car and slide over to the passenger side. Victim complied, and Defendant got into the driver's seat and drove out of the gas station. Victim stated that while he was driving, Defendant held the gun to her back, and described the gun as a large, white, older looking revolver-style handgun. Victim asked Defendant to let her out of the car, and he refused, saying, "I'm gonna keep you." Defendant demanded Victim's purse, and she took out her Venmo debit card on which her name was printed and handed it to him.

Defendant drove around for approximately ten minutes, then pulled to the curb in the 2400 block of Pleasant Avenue South. Defendant kept the gun pointed at Victim, and undid the fly of his pants, pulling his pants down to expose his erect penis. Defendant ordered Victim at gunpoint to perform oral sex and penetrated the Victim's mouth with his penis. Victim determined that she was going to try to escape while this was happening and took a stun gun from her pocket. The stun gun did not work, but Victim was able to get out of the car, and run down the block, calling out for help. A homeowner on the street allowed Victim into his home and called police, while Defendant drove away in Victim's vehicle.

Victim's vehicle was later recovered in a nearby alley after a neighbor discovered it had been abandoned, still running, and contacted police.

A short time later, officers were in the area of the BP gas station at 2000 Third Avenue South, responding to additional reports of carjacking attempts committed by a man matching the description of Defendant. Officers were directed back to the BP gas station by a concerned citizen, who stated that man in a three-hole ski mask was lurking near the gas pumps. Officers approached, and Defendant started to walk away, but was quickly apprehended by officers. A search incident to arrest revealed that Defendant had Victim's Venmo card in his pants pocket.

After Defendant was taken into custody, officers followed the footsteps Defendant had made in the freshly fallen snow to a pick-up truck parked in a nearby driveway. Officers located a revolver-style handgun with a white handle, matching the description provided by Victim. The handgun had been discarded just under the pickup truck on top of the snow. Later examination revealed the handgun to be a BB gun.

Both Victim and Defendant underwent SANE examinations. DNA results are pending.

Defendant is currently in custody.
