On November 18, I was assigned this case. I received confirmation to proceed with the investigation on November 23.

On November 24, Sergeant Mark Osland and I drove to the Victim/Rayann Hayes's house at the listed address. There was no answer at the door. I observed several pieces of mail in the mail box. I left a business card.

We then drove to 1611 Plymouth Avenue North to speak with the residents of apartment 103, 104 and 204.

When I spoke to Witness2/Nekelia Sharp of apartment 103, she clarified some of the names listed in this report. (It should be noted that her statement was recorded by Sergeant Osland, Job# 32418).

Witness 2 told us that she and her husband, Witness 1/Albert Landers were having a party. They invited several people that live in the building to the party, including Witness 5/Darrell Gross (aka Dee), Victim/Rayann Hayes and Jamar Clark.

At some point during the party Witness 1/Landers and Witness 2/Sharp got into an argument. Witness 2/Sharp stated that she asked everybody to leave. As Witness 1/Landers was leaving the apartment building, the argument between Witness 1/Landers and Witness 2/Sharp that turned physical. This occurred in one of the common areas on the first floor.

Witness 2/Sharp stated that while arguing with Witness 1/Landers, Victim/Hayes grabbed her from behind and put her in a bear hug. According to Witness 2/Sharp, Jamar Clark became upset with the victim because she was intervening in their argument. Witness 2/Sharp stated that she walked back to her apartment and left Victim/Hayes and Jamar Clark in the common area.

Witness 2/Sharp stated that Witness 4/Sharice Clark from apartment 104 offered to watch her (Witness 2's) daughter so she could enjoy the rest of her night. Witness 2/Sharp stated that she was walked back to the common area of the apartment building and at some point Jamar Clark reappeared. She stated that his face was bruised. Clark disappeared after the paramedics arrived. Witness 2/Landers stated that she let them inside the building. Moments later she stated that they were escorting Victim/Hayes down from the second floor to the ambulance that was parked on Plymouth Avenue. According to the Witness 2/Sharp, the victim was walking, on her own, and was not being carried by paramedics.

Witness 2/Sharp stated that she was standing in front of 1611 Plymouth when Jamar Clark walked up to the ambulance. Witness 2/Sharp stated that she saw all events that followed.

After completing this interview, we walked up to apartment 204 to speak with OT1/Shamirra Fine (daughter of Victim/Hayes). As we were approaching the apartment on the second floor, two unidentified males were leaving. I asked them if OT1/Fine was in the apartment was there. They stated no and left. I put a business card under the door.

We went back to the first floor to attempt to speak with to Witness 4/Sharice Clark. We were unable to enter the first floor because of the security door. I could see through a window several women talking in the hallway between apartments 103 and 104. Witness 2/Nekelia Sharp opened the security door for us. As we walked toward the women standing in the hall, Witness 2/Sharp identified one of the women as Witness 4/Sharice Clark. As I walked closer to Witness 4/Clark she retreated into apartment 104 and closed the door. Witness 2/Landers told me that she didn't wish to talk to police (based on Witness 4/Clark's reaction as I approached her, I would say this was true).

We then went to 1615 Plymouth Avenue North to speak with Dee, aka Witness 5/Gross (Sergeant Osland recorded the interview Job #32419). Witness 5/Gross stated that he was at apartment 103 for the party. He stated that he left prior to the argument. He stated that he didn't see any of the arguing between Witness 1/Landers and Witness 2/Sharp. Nor did he see any confrontation between Victim/ Hayes and Jamar Clark. He stated that he did see Victim/Hayes being carried out of the apartment building on a gurney and her put into the ambulance. Additionally, he saw the police arrive at the scene and events that followed.

On 11/24/15, I and Sgt. McCarty went to 1223 Morgan Av N in attempt to speak with the victim. The victim was not home and we left business cards.

Sgt. McCarty and I went to 1611 Plymouth AV to speak with witnesses. We attempted to speak with Sharice Clark in Apartment #104 but she refused to speak with us.

Job # 32418

We spoke with Witness Nekelia Sharp in apartment #103. Here is a synopsis of the interview concerning the assault: Witness Sharp said for her birthday her husband through her a party with some of the people who live at the apartment building including Jarmar Clark and Victim Rayann Hayes. Witness Sharp said she normally does not have parties.

Witness Sharp said they were drinking and playing cards and as the night went on she decided to shut down the party because of her little daughter. Her husband was going to leave so she had altercation with her husband. Witness Sharp said it spilled out in the lobby of the apartment building. Witness Sharp said she and her husband were pushing on each other and Victim Hayes grabbed a hold of her to separate them.

Witness Sharp said Jarmar Clark became upset with Victim Hayes about getting in the middle of Witness Sharp and Albert Landers argument. Witness Sharp said Victim Rayann Hayes and Jarmar walked away and she went back to the apartment. Witness Sharice Clark from #104 offered to take her daughter.

Witness Sharpe said she went out in front of the apartment building where she saw Jamar come walking around the side of the apartment building with his face swollen from a fight with Victim Rayann Hayes. Jarmar asked Witness Sharp said Jarmar asked for another drink because his sister Sharice kicked him out for the night. Witness Sharp said she went inside and got him another drink and came back outside and gave it to him.

Witness Sharp was asked if the fight between Victim Hayes and Jamar was heated. Witness Sharpe said it must have been because she could hear the altercation through the walls.

Witness Sharp said an ambulance arrived and went upstairs. Witness Sharp said the paramedic came back down walking the Victim Rayann Hayes to the Ambulance. Witness Sharp said Victim Rayann was walking with a limp to the back of the ambulance.

Witness Sharp continued describing the events of the incident of the night but did not pertain to our investigation so it was not included in this supplement.

Job # 32419

Sgt. McCarty and I spoke with Witness Darrell Gross. Here is a synopsis of the interview concerning the assault: Witness Gross said he was at the party but left before the fight broke out. Witness Gross said later he went outside to the front of the apartment building and observed Jarmar with a swollen face.

Witness Gross said he was told the victim had slammed Jamar's face into the door. Witness Gross said Jamar Clark was upset but was not angry. Witness Gross said the paramedic came by with Victim Rayann Hayes on a gurney but was in a seated position. Witness Gross went more into detail of the shooting incident but is not part of our investigation so it was not included.

On November 25, I received a call from Robert Hill, processes. The following is a summary of his interview.



Job # 32473

He stated that he is the property owner of 1223 Morgan Avenue North and that the victim, Rayann Hayes is his niece. He stated that she doesn't live at this house. He stated that she has been staying and hiding (from police and Jamar Clark's family) at her daughter's apartment at 1611 Plymouth Avenue North, apartment 204.

Mr. Hill said that Victim/Hayes has also been stating at "Grandma's" apartment. He stated that Grandma lives in the townhouses on Plymouth, one block west of 1611 Plymouth Avenue. He did not know Grandma's name or exact address.

On November 30, Sergeant Osland and I drove back to 1611 Plymouth Avenue North to look for additional witnesses who may have further information related to the events prior to the first ambulance arriving on November 15, 2015.

When we arrived at the location, there was a male standing outside the building, this male later verbally identified himself as Albert Landers of apartment 103. Mr. Landers talked briefly about his dissatisfaction with the protesters in front of the Fourth Precinct. Stating in part that they don't care about Jamar Clark

He also would not directly answer my questions about events earlier in the evening. He did however, talking about the get together at his apartment for his wife, Witness2/Nekelia Sharp and that he left the apartment building before the fight between Jamar Clark and Victim/Rayann Hayes began. I asked him if he would let us in the secure apartment building and he refused, stating that he would not help us talk to anybody inside the building. It should be noted this conversation with Mr. Landers was not recorded.

Sergeant Osland and I were able to gain entry in the secured building with the help of maintenance workers.

It should be noted that all the follow interviews were recorded and download by Sergeant Osland.

We went to apartment 201; the following is a summary of my interview with Oliva Scott.

Job #32564

Oliva Scott verbally identified herself as the resident. She stated that she was home the night of November 15. Ms. Scott told us that she did not see or hear anything that happened inside the apartment building.

We went to apartment 203; the following is a summary of my interview with Chala Stroud.

Job #32565

Chala Stroud verbally identified herself as the resident. She told us that she didn't hear or see anything in the apartment hallway unusual on November 15.

Job #32565

We then went to apartment 204 to look for Victim/Hayes. Upon knocking at the door a male answered the door. The male verbally identified himself as Antonio Stanley; the following is a summary of that interview.

Job #32565

He stated that he is the boyfriend of OT1/Shamirra Fine. He stated OT1/Fine and Victim/Hayes were not home. It should be noted that this was the same male we encountered last week walking away from this apartment, at that time I left a business card with him.

Mr. Stanley initially stated that he was not home when the Victim/Hayes got hurt. Moments later he stated that he was upstairs in apartment 104 during the early morning hours of November 15, when he received a called to come down stairs to help the victim. He stated that he saw the victim lying in the 1st floor hallway; he helped her back upstairs to apartment 204 and called an ambulance. He stated that was most likely when she hurt her leg in the 1st floor hallway.

We knocked at apartment 202, there was no answer. I left a business card. Several hours later, I received a call on my cell phone. The number was blocked. An unidentified woman stated that she didn't hear or see anything that happened in the hallway on November 15.

We went to apartment 101. After knocking at the door for a few minutes, an unidentified elderly disabled woman came to the door. It was apparent that the woman was dealing with several medical issues. She stated that that she didn't hear or see anything in the apartment hallway on November 15. The woman stated that her brother, who lives with her but was not home at the present time, may have information. I left my business card.

As we were getting ready to knock on at apartment 104 and man and woman opened the door and emerged from the apartment. I woman that verbally identified herself as Sharice Burns answered the door. She stated that she was the sister (Witness4/Sharice Clark of Jamar Clark). The woman allowed us to talk to her. The following is a summary of that interview.

Job #32567

She stated that she was at home at attending the gathering in apartment 103. She stated that when Witness 1/Landers and Witness 2/Sharp began to argue in the hallway Victim/Hayes grabbed Witness 2 in bear hug. Witness 4 stated that Jamar Clark told the victim to left her (Victim/Hayes) to leave her (Witness2/Sharp) alone.

According to Witness 4/Burns Victim/Hayes rammed Jamar Clark's face into the metal door jamb in the hallway because he was trying to take her away from the situation. Witness 4 stated that Jamar Clark's face was bruised and bleeding as a result of this action. Witness stated that she tried to get Jamar Clark to come back to her apartment and offer him a towel for his face. Jamar was concerned about the Victim because she was intoxicated.

Witness4/Burns stated that the victim kicked at or toward Jamar Clark and that is probably how she hurt her leg. I asked what if anything did Jamar Clark do after this happen. She stated that basically just stood there and tried to console the Victim.

At some point the victim fell to the floor and appeared unable to get up. Witness/Burns went upstairs to apartment 204 and Antonio Stanley came downstairs and carried the victim to the stairwell located on the eastside of the building and most likely upstairs to apartment 204.

After the victim was taken upstairs, she tried to convince Jamar Clark to come inside her apartment, 104, but he refused.

I called him back and received his voicemail. I left a message for him to call me.

I then called his mother, the second at the

I told her I would like to speak with her son. She stated that we (Sergeant Olson) could come to her residence to speak with him. She agreed and we drove to her house in Chaska.

When we arrived I attempted speak with him. The following is a summary of that interview.

We attempted to talk to however he refused to talk to us. His mother, all also tried to get him to cooperate, but he refused. kept saying "I don't want to talk to them." I stopped the interview.

As of this date, we have not made contact with Victim/Rayann Hayes.

Continuing efforts to locate Victim/Rayann Hayes

On December 15, I received information that Rayann Hayes possibly has a niece named Crejonia Larkins. MPD officers provided the addresses of 1211 Morgan Avenue North (units 1 and 2) and 5960 65th Avenue North in Brooklyn Center for Crejonia Larkins.

Sergeant Osland and I drove to 1211 Morgan Avenue North. Upon knocking on the door of unit 1, a woman identified as Cretia Combs, date of birth phone answered. Ms. Combs told us that Crejonia Larkins is her daughter. She stated that Ms. Larkins lives on 65th Avenue North in Brooklyn Park. Ms. Combs also told us that Crejonia Larkins is not Rayann Hayes's niece; instead she described Rayann Hayes as good family friend.

I asked if Ms. Combs if she had any information about Rayann Hayes, such as her current location, telephone numbers, etc. Ms. Combs stated that she did not have any information and went on to say that she believed that Rayann Hayes is either hiding or in protective custody.
