Our 2023 Accomplishments



Created a comprehensive public safety strategy called **Focus on Fentanyl** to combat the lethal fentanyl epidemic.

In partnership with several local law enforcement agencies, opened the **North Metro Regional Public Safety Training Facility** to provide stateof-the-art training.

Created the first **HCSO Youth Community Advisory Board** with high school students from across the county who provide valuable input and perspectives on public safety.

Successfully staffed 81 Twins games and the playoffs at Target Field, and 38 events at US Bank Stadium, including all concerts and **Minnesota Vikings games**.

Added mugshot photos to the jail roster for greater transparency.



Launched the HOPE Hub, a collaborative effort between the county and local nonprofits, which builds upon the Helping Others by Providing Education (HOPE) Program to empower people with the skills and resources needed for selfimprovement upon release from our custody.


Successfully passed legislation to create a position of Major to oversee the Public Affairs Bureau.

Attended more than **500 community events** and successfully established several youth engagement initiatives, including Law Enforcement Exploring, DARE, and various mentor programs.

Expanded collaborative efforts with businesses, places of worship, and schools related to threat assessments and public safety information sharing.

Established a **Joint Enforcement Team** to conduct directed patrols in high-crime areas.

Finance Division

The Finance Division provided fiscal analysis for the agency, developed the fiveyear capital improvement plan, and set the operating budget of 141.2 million for 2023. The Finance Division acts as good stewards of taxpayer dollars by implementing costsaving measures, aggressively seeking federal and state grants, developing efficiencies in operations, and enhancing partnerships in law enforcement and the community. In 2023, the Hennepin County Board adopted the 2024 operating budget of \$160.7 million, as well as HCSO's 2024-2028 Capital Improvement Program. This includes a \$41.9 million Public Safety Services Division Headquarters building, \$6 million to replace aging equipment

Implement an Auto Theft unit in the Major Crimes Division that will have dedicated detectives and crime analysts who will use intelligence-led policing and will partner with other law enforcement agencies to have a meaningful impact on carjackings and auto thefts.

Aggressively combat the opioid crisis through our task forces, investigations, analysts, and the support received from **HCSO's High Intensity Drug Trafficking Area (HIDTA)** designation. In addition, continue the Sheriff's Office's Focus on Fentanyl public awareness campaign 5 **Establish a K9 program** in the jail to detect and deter opioids and other narcotics from entering the facility.

6 Work with county leaders to continue to **support our employees through fair wages** to remain competitive in an ever-increasing demand for qualified personnel.

Proactively pursue grants and alternative funding sources to enhance services and support new initiatives that address our public safety goals. State and federal grant programs offer our agency the ability to innovate and pilot new projects in response to evolving public safety needs. Adequately fund employee wellness programs and increase access to mental health and counseling services for our staff.

Establish the first-ever HCSO satellite office to further engage the community while supporting our strategic priorities, such as opioid overdose prevention and awareness, public safety education, and recruitment.



Division: Enforcement Services

The Public Safety Services Bureau's Public Safety Services Division (PSSD) provides emergency response, patrol service, DWI enforcement, warrant service, civil paper service, and response to in-progress crimes. This division includes several specialized units and functions: 911 Dispatch, Patrol, Water Patrol, Warrants, Transport, K9, Special Operations, School Resource Officer, Hospital Security Enforcement unit, and Commercial Vehicle Enforcement unit. Visit our website for more information on each unit.

PSSD's Patrol unit provides primary law enforcement response to several cities in Hennepin County, and provided patrol support to the cities of Brooklyn Center and Golden Valley due to those cities experiencing staffing shortages. The Patrol unit's contract with Golden Valley has continued into 2024.

PSSD conducted multiple in-house and outside training seminars in 2023, including an agency-wide hostile threat training and mobile field force training. PSSD also conducted trainings on new technologies and equipment and finished the installation of new squad camera systems.



Water Patrol Unit

The Water Patrol unit patrols Hennepin County's bodies of water and assists in search and recovery operations throughout Hennepin County and beyond. In 2023, Water Patrol added Hennepin County medics to Lake Minnetonka patrols on the weekends to make medical aid more quickly available in case of medical incidents. Water Patrol also secured funding for a new Remotely Operated Vehicle with sonar for improved search and rescue capabilities. Water Patrol also worked closely with multiple partners on several water safety education events and swim instruction programs.

K9 Unit

In 2023, two new dogs and handlers joined the unit, bringing the total number of dogs/handlers to 9. In addition, the K9 unit underwent extensive training over the course of the year, such as completing an external certification course through the North American Police Work Dog Association's Minnesota State Workshop.

Special Operations Unit

The Special Operations unit (SOU) coordinates preparation and response to sudden events requiring large-scale law enforcement response. These include active shooters and other threats, emergencies, natural disasters, civil unrest, and large public events. SOU also provides other agencies with training, personnel, and equipment for these types of events.

SOU responds to events like hostage rescue, barricaded suspects, and high-risk arrest warrants. They are trained and equipped to respond to events involving weapons of mass destruction or hazardous materials.

Transport Unit

The Transport unit is responsible for extraditions and prisoner transports. In 2023, the unit was involved in extradition trips to Wisconsin, Illinois, lowa, North Dakota, and South Dakota.

HSEU


The Hennepin Sheriff's Enforcement Unit (HSEU) provides security services in and around multiple hospitals in Hennepin County. Starting in 2023, the HSEU has supported other law enforcement agencies with violent crime that occurs near the Hennepin County Medical Center (HCMC) via daily patrols around the HCMC campus.



Special Deputy Unit

Special Deputies are volunteers who receive special training in various public safety duties, including:

- Search and rescue
- · Horseback-mounted patrol
- Patrol of the county's lakes and rivers
- Community events and parades
- Open houses, citizen academies, and public demonstrations
- · Emergency call outs
- Natural disasters
- · Water safety inspections
- Support patrol operations
- Traffic and crowd control

- Amateur radio operators
- Motorist/citizen assists
- Medical emergencies
- Underwater Rescue Team



911 Dispatch Division

The 911 dispatchers at our Emergency Communications Facility (ECF) identify the needs of the caller and then determine an appropriate level of response by law enforcement, fire, or emergency medical responders. In 2023, all dispatch staff completed a new course or crisis intervention training for dispatchers to help identify callers who are best served by behavioral health programs.

The ECF is also home to the communications technology team. Interoperable radios are essential for communication among first responders during routine calls for service and critical incidents. The HCSO repairs and maintains radios on behalf of dozens of agencies. In total, our technicians maintain about 10 percent of all radios in Minnesota.

Maior Crimes Division

The Major Crimes Division includes the Detectives unit, Gun Permits unit, and task forces, which include two counter-drug task forces and the Violent Offender Task Force (VOTF). In 2023, the VOTF participated in more than 40 focused enforcement details targeting violent crime. As a result of those details, over 530 arrests were made and over 190 firearms were seized. The VOTF also seized more than 114,000 counterfeit fentanyl pills and approximately 16 pounds of powdered fentanyl.

In 2023, HCSO's drug task forces seized over 21,000 counterfeit fentanyl pills and over 4,722 grams of powdered fentanyl. HCSO also trained in two new task force officers in July 2023.

Criminal Intelligence Division

The Criminal Intelligence Division (CID) assists in the prevention and suppression of criminal activity by providing timely and accurate analyses of criminal information to law enforcement. The division analyzes information to identify crime patterns, forecast criminal trends, generate investigative leads, assist with identification and apprehension of suspects involved in criminal activity, provide timely information sharing on threats to our communities or officer safety, and more. In 2023, the CID received grant funding to expand its auto theft prevention team.

The CID oversees the HCSO Shield Program, which is part of the Global Shield Network (GSN). The GSN and HCSO Shield leverage partnerships between law enforcement and private sector security for information sharing, suspicious activity reporting, and crime prevention, while also respecting and protecting the privacy rights of county residents. In 2023, the GSN hosted the inaugural Global Shield Network Awards, during which the HCSO Shield received a Unit Citation Award for exceptional performance.

Forensic Science Laboratory

The Hennepin County Sheriff's Office Forensic Science Laboratory (FSL) provides forensic services to more than 35 suburban law enforcement agencies, the Minnesota State Patrol, and several federal law enforcement agencies. The FSL is one of only seven accredited crime laboratories in Minnesota, and one of only four in the state accredited to perform DNA analysis. The FSL has also earned international accreditation. In 2023, FSL staff hosted multiple clinics to help lawyers and legal professionals better understand forensic evidence. Staff also upgraded several key pieces of equipment and began planning for a project to expand the lab's property room in 2024.

Professional Standards Division

The Professional Standards Division (PSD) staffs and trains HCSO employees. Applicants to open HCSO positions receive a background check conducted by the PSD's Background unit. In 2023, the Background unit completed 234 pre-employment background investigations and 293 contractor/vendor access checks. Professional Standards assisted with the 142 reported injuries to staff and the processed documentation for the 142 people who resigned or retired from HCSO.







The PSD is also responsible for implementing policies and procedures to ensure that HSCO stays at the forefront of 21st Century Policing.

The HCSO and other law enforcement agencies use a training facility in Maple Grove for skills development and certification. In 2021, the PSD assisted with the design phase for an expansion of this facility. It opened to HCSO personnel in July 2023. It provides more than 20 law enforcement agencies the tools to undertake modern training that is being demanded by the public. This includes a space designed for realistic, scenario-based training that will be used to teach de-escalation techniques and defensive tactics, as well as a virtual simulator room and a twelve-lane range expansion.

Adult Detention Division

The Hennepin County Sheriff's Office operates the largest jail in Minnesota. It is accredited by the American Correctional Association, which signifies that we maintain the highest standards of inmate custody and care. In 2023, the Adult Detention Division (ADD) completed multiple projects to update the jail's facilities and technology, including adding more space and technology for classrooms, a new pager system for deaf/hard of hearing residents, new security cameras with higher resolution and better viewing angles, and more.

The ADD includes the HOPE Program, which stands for Helping Others by Providing Education. This program offers formal education and life and job skills courses for those in our care to help them more successfully reenter the community after leaving our facility. The program includes a full-time teacher from Minneapolis Public Schools to help inmates work toward completing their GEDs. The goal of the program is to help put inmates on a path toward better lives upon leaving our facility. Reducing recidivism among our inmates makes the entire community safer. The program is overseen by Sgt. Adam Hernke, who was named the Minnesota Sheriffs' Association Programmer of the Year for 2023. Through the HOPE Program, 2,529 classroom contact hours for GED classes were completed in 2023 and four high school diplomas were issued.

The Adult Detention Division also includes Central Records, which tracks information on all persons booked into or discharged from our jail. There were 25,123 bookings in 2023.



Court Services Division

The Court Services Division provides law enforcement services to the Fourth Judicial District Court to ensure that the judicial system operates in a safe and orderly manner. We provide security for judges, juries, witnesses, personnel, and all visitors in approximately 96 courtrooms across multiple facilities. We address security concerns with judges and court personnel, conduct patrols and security checks in the courthouses, and assist with screening for weapons. The year 2023 was in many ways a return to normal operations after the COVID-19 pandemic. Most COVID protocols were rescinded in 2023, although court appearances via Zoom have continued and remain a popular option.

In 2023, the Court Services Division was named the 2023 Court Security Agency of the Year by the National Sheriffs' Association.

Public Affairs Bureau

The Community Outreach and Public Affairs (COPA) Division plays a critical role in the Sheriff's Office's approach to achieving and sustaining gains related to public safety by strengthening community relationships and building trust. The division partners with community leaders, civic organizations, schools, faith-based groups, block associations, and concerned citizens to collaborate and collectively develop solutions to opportunities that arise within the County's many diverse communities. COPA also provides young people with enrichment opportunities to foster healthy relationships and support a reduction in youth crime.

The COPA team attended more than 40 recruitment events and more than 550 community events in 2023. COPA partnered with outside organizations to work at food shelves, lifejacket giveaways, Toys for Tots events, Hooked on Fishing, and much more. Two COPA deputies were certified to teach the Drug Abuse Resistance Education (DARE) program, and COPA also introduced Casey, the agency's first mascot.

Explorers

The Hennepin County Sheriff's Office Law Enforcement Explorer Post #3744 is a vouth organization sponsored by the Sheriff's Office and the Boy Scouts of America and supported by the Hennepin County Sheriff Foundation. The program relaunched in 2023 after being put on hold during the COVID-19 pandemic. The Explorer Post provides young people (ages 14-20) an opportunity to learn about the law enforcement profession through volunteer service. Members of the Sheriff's Office serve as advisors and liaisons between the Sheriff's Office and the Explorers. The Explorers train for competitions covering topics such as crime scene searches and accident investigations with other Explorer Posts from law enforcement agencies across the region.



Data and Technology Division

The Data and Technology Division was newly created in 2023. They oversee research and implementation of all HCSO software and hardware projects. These projects include everything from equipping HCSO's physical locations with updated video conferencing equipment to evaluating new productivity software or systems for management of incident reports and videos. The Data and Technology Division also includes the Data Practice unit, which oversees and processes any requests for public data generated by HCSO. In 2023, the Data Practice unit completed more than 2,700 data requests. Additionally, this division ensures Sheriff's Office policies are reviewed regularly and align with Federal mandates, State statutes, and best practices.

Tri Wellness Unit

Tri Wellness is HCSO's internal wellness unit. which is focused on providing wellness resources and opportunities that benefit the mind, body, and spirit of HCSO employees and their families. Tri Wellness was founded with the mentality that healthy public safety employees provide better services to their community. The unit includes a fitness coach, a staff clinician, on-call chaplains, and a peer-to-peer support network. In 2023, the peer support team underwent guarterly training guided by our in-house clinician to ensure all participants are up to date on best practices for peer-to-peer support. The team also responded to several traumatic or critical incidents involving our staff members to provide support and resources. Additionally, the Tri Wellness unit leads the Sheriff's Military Activation and Reintegration Training (SMART) program. The SMART program works to support our military and veteran employees and their families.





Community Programs

Focus on Fentanyl

Opioid overdoses are now the leading cause of death in the U.S. for people under the age of 50. According to the Department of Health and Human Services (HHS), 650,000 opioid prescriptions are dispensed on an average day in the U.S. HHS estimates that 3,900 people initiate the nonmedical use of prescription opioids every day. In recent years, fentanyl has emerged as the major driver of overdoses and opioid-related deaths. In 2023, HCSO launched the Focus on Fentanyl initiative, which educates the public on the human costs of fentanyl, as well as what we're doing to fight it.

HCSO's overdose prevention program includes strategies to keep these drugs out of the wrong hands, treating those with opioid use disorder in the jails, and using tools to prevent fatal overdoses. HCSO offers in-person and online training classes, and mails Deterra drug disposal bags to anyone who wants to safely dispose of unwanted medications. Community Programs

Cops Don't Call for Cash

Cops Don't Call for Cash is a program dedicated to fighting a common type of phone scam: individuals posing as law enforcement agencies and demanding payment for a missed court date, jury duty, or other legal matter. The program is focused on educating the public on the fact that law enforcement agencies will never contact individuals via phone or email to ask for any kind of payment. If individuals receive such a call, they should remember the phrase "Cops Don't Call for Cash," and refuse to provide any personal information or make any payments to the caller.

Stickers for Special Needs Residents

We offer free stickers for your front door or window so first responders know someone with a disability lives there. You can request four types of stickers for an occupant who may:

- · Be autistic or have special needs
- · Be deaf or hearing impaired
- Have dementia or Alzheimer's
- Be a person with a disability

Community Advisory Board

The Community Advisory Board (CAB) is a diverse group of residents who provide community feedback and participation in the development of our practices and policies. The work of CAB members includes:

- Identifying and discussing community public safety issues
- Acting as policy advisors
- Providing feedback on Sheriff's Office initiatives
- Contributing to Sheriff's Office strategic planning
- Working as ambassadors in their communities to help educate others about the Sheriff's Office

In 2023, HCSO launched its first-ever Youth CAB, which focuses on areas of concern specific to young people in Hennepin County. Comprised of high school students from across the county, the Youth CAB provides valuable input and perspectives on public safety.



Dawanna S. Witt

Dawanna S. Witt was sworn in as Hennepin County Sheriff on January 3, 2023. She is the first woman and person of color to hold the office.

Sheriff Witt's law enforcement career began in 2000, when she was hired as a detention deputy in the Hennepin County Jail. In 2004, after returning to school to become a licensed peace officer, Sheriff Witt was hired by the Dakota County Sheriff's Office. During her career at Dakota County, she worked in a variety of roles, ultimately becoming the first woman in the agency's history to reach the rank of captain.

Sheriff Witt returned to the Hennepin County Sheriff's Office in September 2019 to take charge of the agency's largest bureau, Adult Detention and Court Services. In 2022, Hennepin County voters overwhelming selected her to be the next Hennepin County Sheriff. She campaigned on her years of experience and a platform of safer communities, improved law enforcement recruitment, and retention, reform, collaboration, and transparency.

Sheriff Witt holds undergraduate degrees in chemical dependency and family therapy and police science, and dual master's degrees in public safety administration and management. She also works as an adjunct professor at Inver Hills Community College, teaching Juvenile Justice and American Corrections.


Volunteer
