### Main Drain/Suction Outlet Cover Documentation Form

Hennepin County would like to help assist pool owners and operators in gathering paperwork and documentation needed to meet MN Statutes 2024, section 144.1222 and Suction Outlet Fitting Assembly (SOFA) requirements.

During your routine inspections and pool openings moving forward, Hennepin County will be checking for the following main drain cover and equalizer cover information found below. If you do not know or cannot find the needed information, we suggest that you reach out to your cover's manufacturer, the company who installed your cover, and/or you may be able to dive into your pool to check your cover's data plate.
