# Form CR-4C10 Instructions

## **Properties that May Qualify**

Properties may qualify for classification 4c(10) if the conditions described in the declaration are met. A restaurant and up to 3 acres of land situated on a lake may qualify provided the business is either:

- Not devoted to commercial purposes for more than 250 consecutive days; or
- 60 percent of its annual gross receipts (including alcohol sales but excluding gift shop sales) must be from business conducted during four consecutive months.

The qualifications must be met based on the previous year's sales information.

## **How to Apply**

Complete the declaration on the front of this form and submit it to your county assessor by February 1 to be eligible for the same assessment year (i.e. apply by February 1, 2014 to be eligible for the 2014 assessment year, taxes payable 2015).

### **Required Documentation**

Your assessor may ask you for information including, but not limited to, sales information and receipts in order to determine your eligibility and the accuracy of your declaration.

You do not have to provide this information. However refusal to do so could disqualify you from qualifying for the 4c(10) classification.

#### **Penalties**

Making false statements on this application is against the law. Minnesota Statutes, Section 609.41 states that anyone giving false information in order to avoid or reduce their tax obligations is subject to a fine of up to \$3,000 and/or up to one year in prison.

#### **Use of Information**

The information on this form is required by Minnesota Statutes, section 273.13 to properly identify you and determine if you qualify for this property tax classification. If you do not provide the required information, your application may be delayed or denied. Your County Assessor may also ask for additional verification of qualifications.
