Hazardous Waste Generator Citation Payable Fines Instruction Sheet

Commercial Hazardous Waste

If you receive a citation for violating hazardous waste rules, you have 30 business days to respond from the time the citation is entered into the district court's records. In addition to resolving the citation itself, you must also take action to correct the violations which resulted in the citation being issued. A more significant enforcement action is likely to occur if same or similar violations occur in the future. Citations are issued for violations of Hennepin County Ordinance Seven and Minnesota Hazardous Waste Rules, Chapter 7045, as incorporated by reference in the ordinance.

To find out if your citation has been entered or to find out your total fine amount:

A) Visit *www.mncourts.gov* select 'pay fines'

OR

Hennepin

B) Call the Criminal/Traffic Court at 612-348-2040 and have your citation ready

There are two options for responding to and resolving a citation:

- **Option 1** Plead guilty and pay the scheduled fine online, by phone, through the mail, or in person
- **Option 2** Meet with a hearing officer to plead guilty and offer an explanation or discuss with the hearing officer your options for contesting citations.

Option 1: To plead guilty and pay the scheduled fine.

Online – You can pay your citation (ticket) online by transferring funds from your checking or savings account, or by using Visa or MasterCard. The Citation Payment System can also be accessed with your smart phone, tablet or other web-enabled device.

Visit the MN Courts page at *www.mncourts.gov* select pay fines and enter your citation number.

Phone – You can pay your ticket or citation with a Visa or Mastercard by calling 612-348-2040, and following the prompts. Be prepared to wait as hold times are sometimes lengthy.

Mail – DO NOT MAIL CASH. Make check or money order payable to: "District Court Administration" and mail your payment, with a copy of your ticket, to:

In Person – Payments can be made in person at one of the five court locations listed on the right side of this document. You can pay in person with:

- cash
- check or money order (payable to "District Court Administration"), or

Option 2: Schedule an appointment with a hearing officer

Call 612-348-2040 to set up a time to meet with a hearing officer.

Note that walk-in appointments are only accepted at the Government Center location and wait times can be an hour or longer. Please plan accordingly for a long wait before you arrive.

When does the 30 business days deadline begin?

You have 30 business days to respond to a citation; this time period does not begin until the Violations Bureau has entered your citation into the court's records. Once you receive the citation, please be patient and allow up to 10 business days for your citation to be entered. It is only when the citation has been entered that you can learn the exact fine amount and pay by credit card, check or money order.

How do I find out the amount of my citation?

An additional \$75 of court-generated surcharges and fees have already been added to each fine. However, do not make a payment until you know the exact fine amount, as surcharges and other fees can change. Please visit *www.mncourts.gov* or call 612-348-2040 to determine your total fine amount. Partial payments will carry over as a balance owed and your citation will remain unresolved.
