- 1. Today's agenda and the meeting summary from March 26, 2024 were approved with a quorum present.
- 2. Out of Hospital Cardiac Arrest Care project (OHCA) Next east and west metro coordination meeting will be scheduled this summer. Staff will send out possible times in June for a joint meeting and a separate EMS Council Medical Directors committee meeting, if desired.
 - Dr. Tanghe met with Hennepin County Fire Chiefs to provide an update on North's approach to OHCA care multiple defibrillation strategies, pad placement, Elegard, and ECMO. Fire Chiefs are interested in finding out how each 9-1-1 EMS provider is utilizing different treatments options for OHCA.
- 3. TXA Protocol Dr. Simpson shared two recent presentations with data on prehospital administration of 2 gram IV bolus, which has been shown to yield better outcomes. There isn't a single protocol currently used by all 9-1-1 EMS providers.

- 4. MIST report All providers support the use of MIST; pre-hospital administration of TXA was noted as one example of the usefulness of this report because pre-hospital medications are not consistently entered into EPIC, and can be missed when care is transferred.
- 5. Pediatric patient dispositions –There has been some confusion among a few medics about pediatric patients who choose to go to MHealth Fairview UMMC and should now be brought by EMS to Masonic, not to Riverside for psychiatric care anymore.

There have not been changes regarding patient choice of hospital within Hennepin County or whether any hospitals will accept pediatric (under age 18) patients. All hospitals in Hennepin County accept pediatric patients, however, some hospitals have specialized pediatric care that can offer faster and/or more comprehensive care for some patient conditions.
