6. **Committee Chair Updates**

A. EMS Medical Directors – Dr. Pete Tanghe

The committee continues to discuss different options in pre-hospital cardiac arrest care, will review a HCID plan with MDH at its next meeting, and will identify a performance measure for quality assurance and improvement by Nov. 2025.

C. Operations and Communications Committee – Tony Martin
The committee is working with hospital partners to update the hospital destination
matrix, the EMS Council Communications Policy, and the ED contact list.

D. Quality Standards Committee – Mike Morelock

The committee reviewed stroke and trauma performance data. All EMS providers consistently meet the 20 minute time on scene benchmark, which is based on the Office of EMS performance indicators. The committee will consider if a different benchmark for the metro area would be useful to better identify runs that may need additional inquiry as QI opportunities. The committee will work with Staff on a performance score cards or reports that could be sent to partners to provide updates about EMS performance in the County after at least one year of data is collected. These data will also be presented to the County Board, as requested, by the end of 2025.
