Chronic homelessness provider guide

If you are a Hennepin County homeless service provider supporting households experiencing chronic homelessness, this document will guide you through how to connect with chronic case conferencing to access housing resources for clients.

If you are serving someone who is chronically homeless, ensure that information is tracked in HMIS by completing the disability questions and accurately reporting entry/exits and current living situations.

Ensure all vital information for your clients is up to date in HMIS

This includes updating the case managers tab, ensuring essential documents are uploaded, completing a Coordinated Entry assessment, and adding information on housing choice and eligibility.

Matching a household to resources

Households are prioritized in chronic case conferencing based on multiple factors. See the following page for a prioritization and tiebreaking schema.
