## Community Emergency Services

#### Community Emergency Services provides:

- Food Programs
  - Food Market Appointment-based model, with walk-ins welcome. Visit 2x per month (no service boundaries)
  - Locker Program Order online and schedule your pick up
  - Meals On Wheels Seniors & those with disabilities (eligibility criteria & service boundaries apply)
- Household supplies at the time of Market appointment (dishware, pots & pans, bedding, towels, etc.)
- Diapers when available at the time of Market visit
- Donated Backpacks/School Supplies when available (late summer)
- Donated "Winter Gear" when available (late fall)
- Pet food/supplies distributed through our Ani-Meals Program for those who enroll in Meals On Wheels
- We help anyone in need, no matter where they live.

## Hennepin County Elections

- Voter Outreach and Engagement is a division of elections that focuses on helping to engage residents of Hennepin County with the information they need to vote.
- Some of our activities include tabling at libraries, giving trainings to community partners on topics such as registration, voting while unhoused, and accessible voting options.
- We also contract with over 30 community organizations to provide voting resources to the communities they serve.
- People can register to vote by either filling out a paper application or go to <a href="mailto:mnvotes.gov/register">mnvotes.gov/register</a> to register online.
- For voters that are not yet registered, they can register at an early voting location, or at their polls on election day. They will need to bring a photo ID and document showing residency (can be found at <a href="mailto:mnvotes.org/register">mnvotes.org/register</a>) or come with a registered voter from the same precinct who can vouch for them.
- People can find their election day polling location at <u>pollfinder.sos.state.mn.us</u>. Or they can vote early. Hennepin County residents can vote at Government Center, or their city hall. Some cities like Minneapolis have their own early vote center and one day pop-up voting sites.

### Metro Transit

- The Transit Assistance Program (TAP) is designed to make Metro Transit buses and light rail more affordable for people with lower incomes.
- TAP provides a reduced fare pass on a Go-To Card. It allows customers to use a bus or train for just \$1 per ride even during rush hour with a  $2\frac{1}{2}$  hour transfer. The discount lasts a full year.
- Requirements:
  - Show a photo ID card or utility statement with your name and address and an accepted document (see <a href="https://www.metrotransit.org/tap-riders">https://www.metrotransit.org/tap-riders</a>) to show that you meet the income guidelines.
  - Once approved, Metro Transit will add the discount pass to a new Go-To card or your existing card then just add value and go!
- Individuals can apply on their own, either in person at one of our transit Service Centers or online. For information about the program or to apply online go to <a href="https://www.metrotransit.org/tap">https://www.metrotransit.org/tap</a>.

## Mid-Minnesota Legal Aid

- We provide free civil legal services (including lawyers and representation) in nine practice areas, for:
  - Lowest income residents of central Minnesota
  - Seniors, 60 and older, in central Minnesota
  - All Minnesotans with disabilities
  - Youth.
- We also provide general information and guidance to all Minnesotans seeking taxpayer assistance or health care coverage.
- We follow federal poverty guidelines for clients who are eligible for our services based on income. However, clients 60 and older and those with disabilities do not need to meet income guidelines.
- Residents across the state of Minnesota, regardless of income, may benefit from: our following programs:
  - Project Care program, which helps Minnesotans find affordable health care coverage
  - Low Income Taxpayer Clinics (general information)
  - Youth Law Project

## Minnesota Department of Commerce – Energy Assistance Program

Minnesota Department of Commerce – Energy Assistance Programs offers the following resources:

- Bill payment assistance for home energy costs (e.g., electricity, natural gas, propane, fuel oil).
  - If eligible, we can pay a portion of your home energy bill, an average of \$550 per household.
- Emergency bill payment assistance to prevent loss of heat (e.g., energy utility disconnection, running out of heating fuel)
  - Up to \$600 per eligible household.
- Repair/replacement of heating systems that are not working for homeowners only
- Resources are available for the entire state, for both homeowners and renters.
- Eligibility is based on household income below 50% of the State Median Income (e.g., \$35,799 for a household of one, \$68,845 for a household of four)

Also, at <a href="mailto:mn.gov/home">mn.gov/home</a> there are program details, outreach flyers, and videos on how to apply online available in English, Hmong, Somali, and Spanish.
