It is illegal to put this kind of waste in your household garbage.

## Use compostable bags

Accepted: Dirt, leaves, rock aggregate under 2 inches in diameter, tree logs and waste under 10 inches in diameter.

# Options for managing yard waste

- Curbside pick-up: Contact your waste hauler or city recycling coordinator to see if they offer curbside pickup.
- Yard waste drop-off sites: Hennepin County does NOT operate a yard waste drop-off site. To find drop-off sites available to you, see the listings inside this brochure or go to hennepin.us/yardwaste.
- Compost in your backyard: Use a compost bin for your garden, yard and food waste. More information about backyard composting can be found here: hennepin.us/composting.
- Leave grass clippings on your lawn: This practice will add valuable nutrients and can reduce the need for fertilizers

Storm drains flow directly to local lakes, rivers, and wetlands. Don't let trash and extra organic pollutants go down the drain. Keep your storm drains clear of leaves, pet waste, and other debris to reduce water pollution.

#### Ash tree waste removal

Any ash tree that is not being treated will eventually need to be removed. Trees should be removed by a reliable, insured, ISA-certified arborist. Dead trees should be removed before they become hazards. Working with your neighbors to hire a company to remove trees on multiple properties can help reduce your individual costs.

Ash tree waste should be disposed of at yard waste sites within the county and shouldn't be transported outside of the Twin Cities metro area to avoid spread of emerald ash borer.
