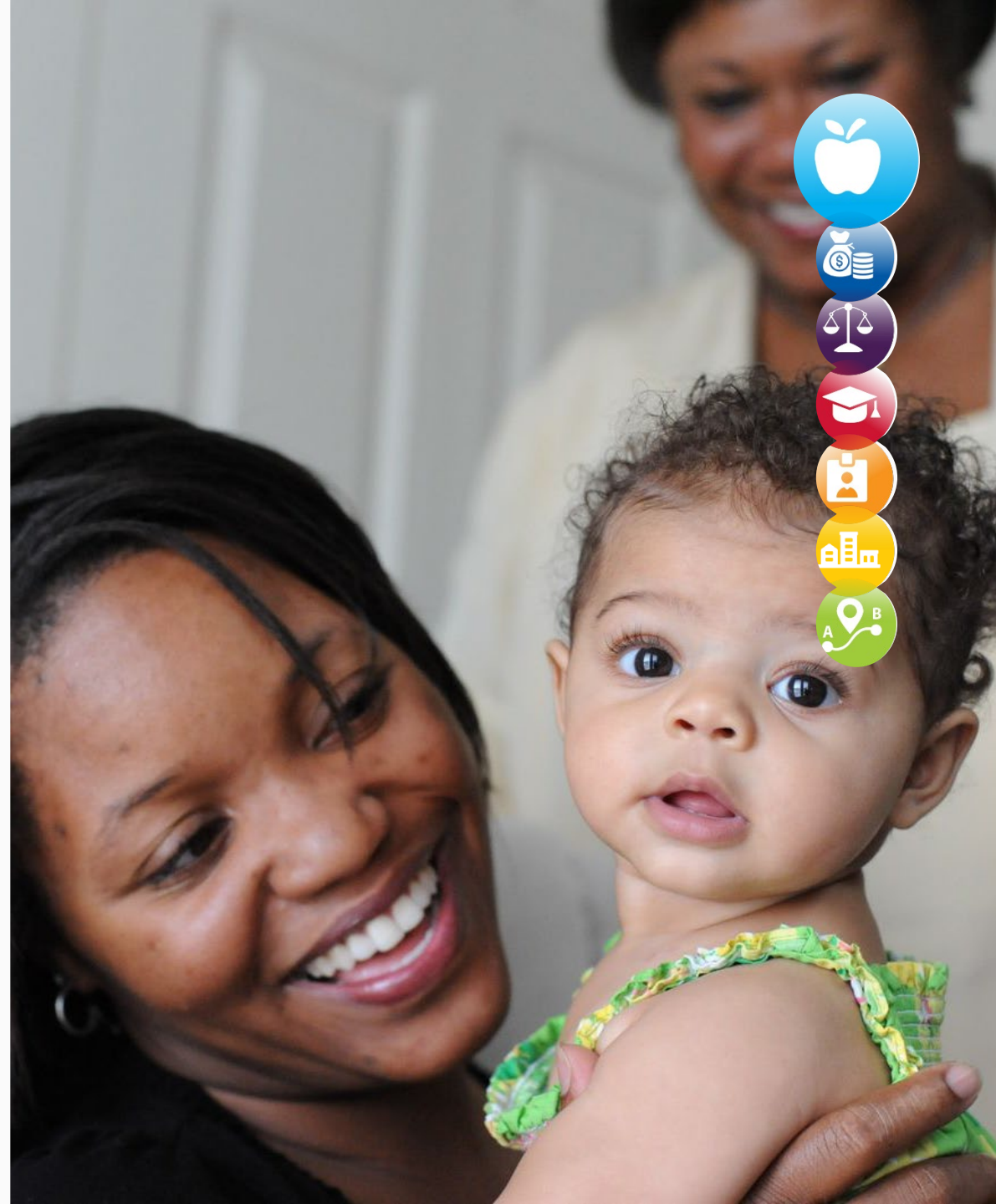

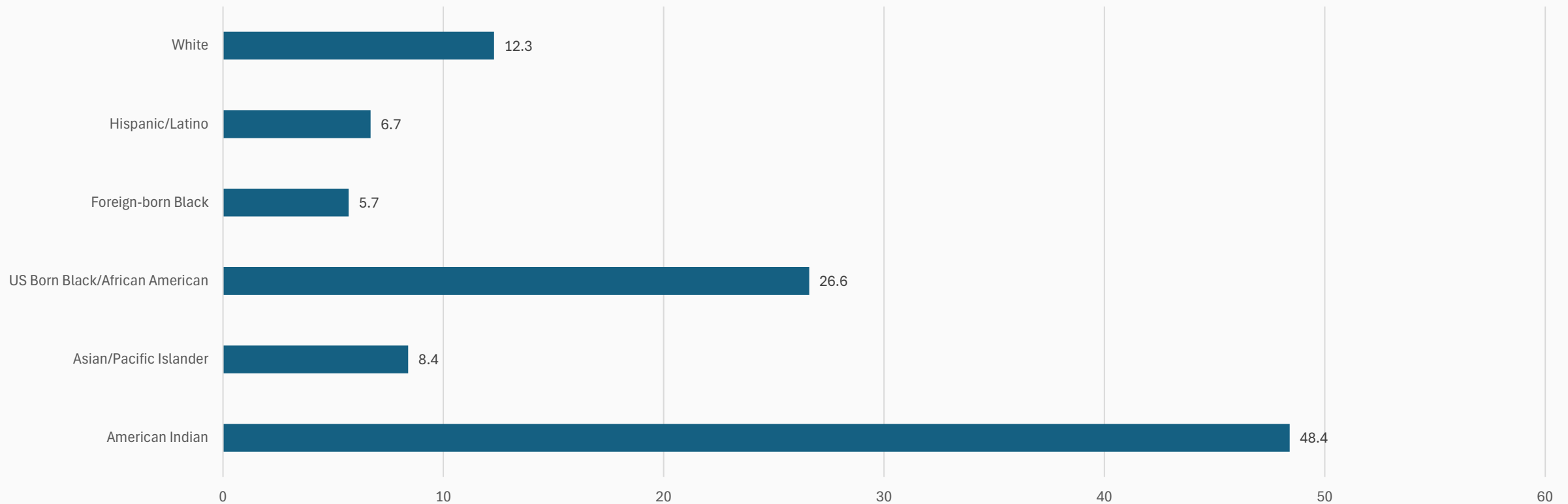

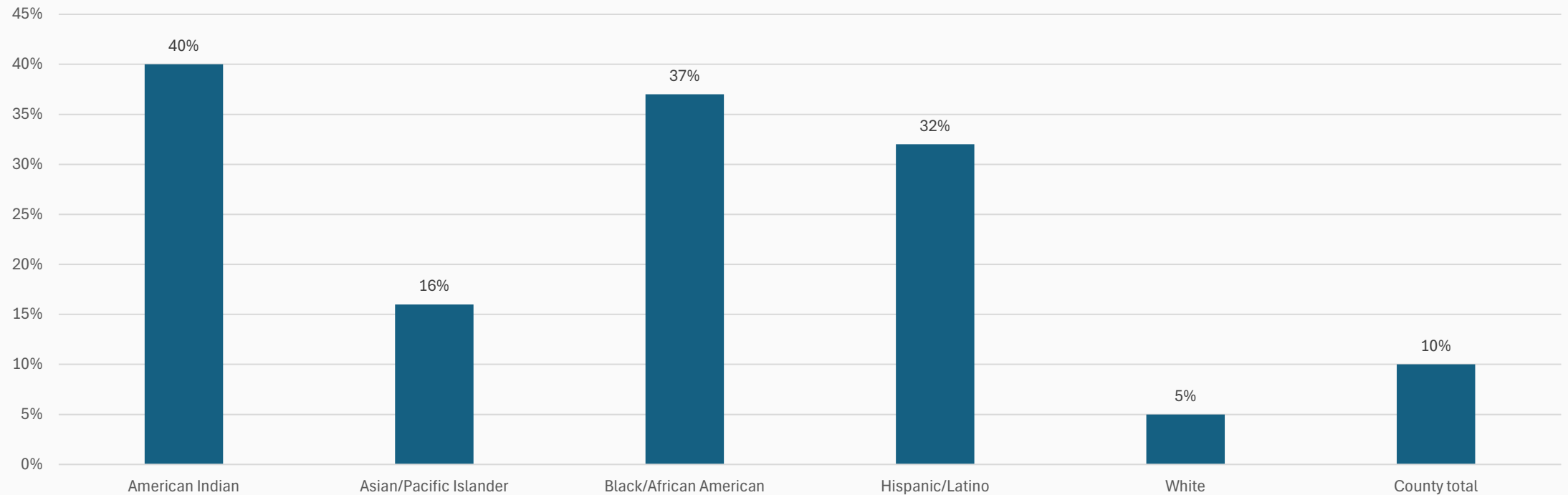
Community indicator: Heart Health

Age-adjusted death rate due to heart disease per 10,000 by race/ethnicity

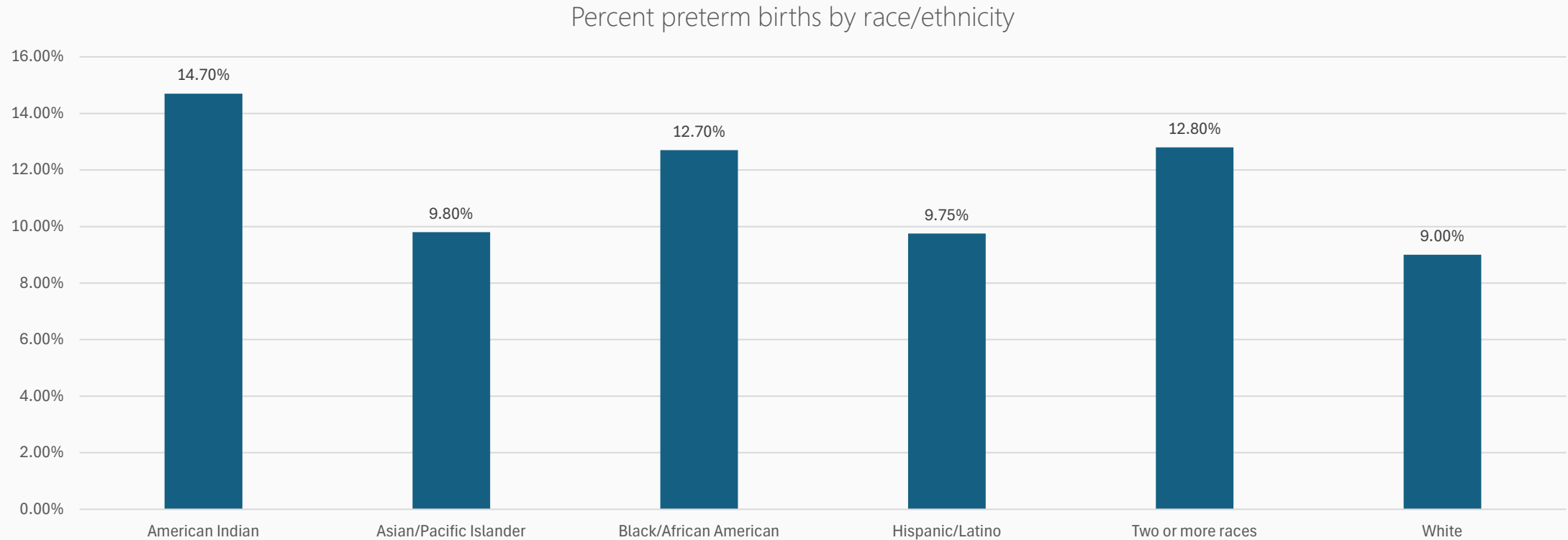


Community indicator: Food Insecurity

Improve health and reduce disparities by addressing food security and access to healthy, culturally relevant food for Hennepin County residents.



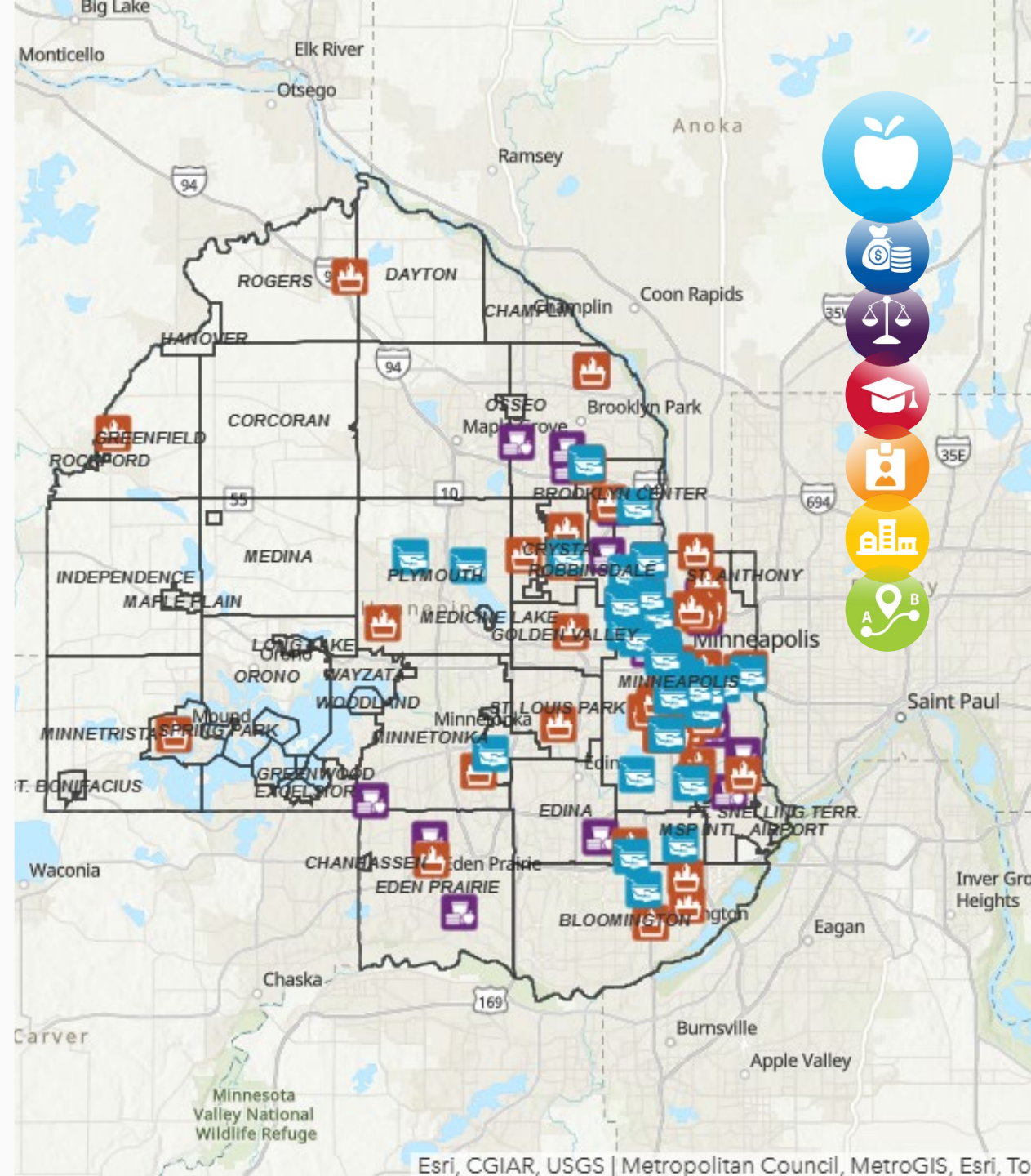
Food security policies

- Healthy Food Guidelines
- Growing Communities – Urban agriculture using county managed land
- SNAP administration
- Recycling Ordinance 13 – food donation from businesses
- Monitoring federal impacts



Food security practices

- Outreach, Engagement, and Education
- \$4.9 million funding
- 43 community organizations
- Food resource map
- Business and school food waste prevention programs



Heart Health Initiative

- Heart disease is one of the leading causes of death in the U.S.
- Black/African American and Indigenous women face significantly higher rates of heart disease



Heart health policies

- Board investment of \$2 million for 2024-2025
- Community developed and implemented strategies
- Partnerships with 18 community organizations and clinics to improve heart health



Heart health practices

- Public awareness campaign that centers experience of African American/Black and Indigenous women
- Culturally-relevant care coordination and clinic prevention services
- Community-based social support, physical activity, nutrition education, and cultural activities
- Support groups for post-cardiac event survivors



Heart health results

- Deep community trust building and partnerships
- Relationship between heart health and mental health
- Increased community awareness of risk factors for women

Maternal Health Initiative

Maternal health policies

- Investing in community-initiated solutions
- Implementing the birth justice plan
- Sustaining a local coalition of maternal health and birth justice champions
- American Indian Birth Center
- African American HomePlace
- Birth Justice Community Advisory Board (2026)



Maternal health practices

- Expanding existing programs focused on improving maternal health outcomes and experiences
- Supporting pilot programs and projects in the birth justice plan
- Expanding reproductive services and navigation at Public Health Clinics



Maternal health results

- Over 5,800 patients served through contracted providers and Public Health Clinical Services
- 2,469 individuals received 3,744 referrals to resources
- 63,498 culturally congruent food bags distributed to address food insecurity
- 5,627 community members and health care professionals attended trainings and educational sessions
- Over \$3.8M invested in direct services, community education, and cross-agency collaboration to support birth justice
