Renters Rights Legislation - Deran and Larry introduce topic

• Housing Committee will provide a summary of renters rights legislation being considered at the Capitol. They would like to ask the Hennepin County board to support this legislation. Two representative in state house and one senator

sponsor have a few files in the mix that speak to address the not up to date on current renters right in Minnesota. Big ask a memo to county board th hamve them join the house and senate in supporting these initatilve.

- Address key areas
 - Eviction expungement and pending enviction. No notice to tenants required before eviction and then that eviction will forever appear on a tenant's record.
 - Heat and repairs regulated by local ordinances and this seeks to have a statewide framework, emergency repairs amended to include operating refrigerator, air conditioner, and when the building is deemed unsafe.
 - Lease fairness rent advertised a certain amount, when lease is ready to be signed additional fees are added on to the rent amount quoted fees should be allowable only for tangible services provided to the tenant and told upfront when rent quoted.
 - Access to tenant apartment must give reasonable notice, must give a definite time to enter.
 - Infermity to exit lease with a two week notice in some cases of infermity.
- If we approve the REAC supporting this legislation and have county support also, will REAC members have input into the memo before it is submitted? Yes.
