Landscape of Homelessness Risk in Hennepin County

Severe Housing Cost Burden: 60,000 low-income renter households spending at least 50% of their income on housing-related costs


Precarious Housing: Estimated 10,000 residents in temporary, unstable housing with family or friends

Institution-to-Homelessness Pipeline: 15% of homelessness episodes are the result of exits from carceral, treatment, and other institutional settings (e.g. foster care)

Key terms and acronyms

- Homelessness Prevention (1) promoting stable housing by increasing protective factors for those with highest risk of future homelessness and (2) helping those who are at imminent risk of homelessness resolve housing crises.
 - Eviction Prevention a set of strategies and programs designed to help people at risk of losing their homes to stay housed, often by providing financial assistance, legal aid, and mediation.
- Area median income (AMI) Set by the Department of Housing and Urban Development (HUD) each year, based on household size.
- Case management A collaborative process to plan, secure, monitor, and evaluate the options and services required to meet a person's needs.
- Emergency rent assistance (ERA)— Programs that provide rent assistance to low-income Hennepin County residents. Including but not limited to: Family Homeless Prevention and Assistance Program (FHPAP), School to Housing, County emergency assistance (EA/EGA).
- School to Housing (STH) Homeless prevention resources for families with school-age children, funded through Local Homeless Prevention Aid.
- RentHelpHennepin (RHH) Hennepin County's coordinated emergency rent assistance application and payment system.
- Housing and Development Software (HDS) The vendor who created and supports RHH.





2020 to 2024 changes impacting eviction prevention

2020

- Annual ERA: ~\$5M
- 10% legal representation
- Many different applications for ERA
- Few tenant protections
- Minimal rent/mediation/legal coordination at court
- No targeted school-age ERA

2024

- Annual ERA: ~\$14M (plus add'l \$13.5M RentHelpMN)
- 100% legal representation
- Central application for FHPAP, STH, and other
- Tenant protections 2024 14-day notice, more clarity in lease costs/fees, etc.
- Rent assistance and mediation available before and at all pre-trial eviction hearings
- Access to ERA through elementary schools


