# Out-of-Home Placement & Screening Trends Q3 2018

### Total Out of Home Placements


Figure 1<sup>1</sup> shows the breakout of out of home placements. Overall, there were 179 out of home placements in quarter three of 2018. Twenty-four percent were Hennepin County placements, 65% were Greater Minnesota placements, and 11% were out of state placements.



# **Closed Placements**

Figure 2<sup>2</sup> shows the breakout of closed out of home placements (those which ended). Of the 179 total placements, 52 closed during quarter three of 2018.


Twenty-seven percent of the placements that closed were Hennepin County placements, 60% were Greater Minnesota placements and 13% were out of state placements.

The average length of stay (average number of days in placement) for youth with placements that closed during quarter three of 2018 is shown below. The average length of stay for youth of color (n=51) was 186 days. The length of stay for the one white youth was 262 days.



# **Open Placements**

There were 127 youth in placement on the last day of the quarter (September 30, 2018).




#### Figure 3. Open Out of Home Placements Q3 2018

Twenty-three percent of open placements were youth in Hennepin County, 67% were youth in Greater Minnesota placements and 10% were in an out of state placements (see Figure 3).

A majority of youth in Hennepin County on September 30<sup>th</sup> were at the CHS (62%). Roughly 7 in 10 (71%) youth placed in Greater Minnesota were in an RTC, as were slightly more than three-quarters (77%) of youth placed outside of Minnesota.

The chart below shows the number of male and female youth in out of home placement on the last day of the quarter (September 30, 2018).




#### Youth in out-of-home placement at quarter end by sex




### Screening

Youth receive a placement screening to determine if an out-of-home placement is recommended<sup>3</sup>. The chart below shows the number of placement screenings conducted on youth by quarter. There was a 68% decrease in screenings between Q3 2013 and Q3 2018. Youth who are sent directly to placement as a court order are not included in the chart.



<sup>&</sup>lt;sup>3</sup> At times a youth may be screened for more than one placement on a single day. These records have been counted as duplicates and have been removed for analysis.


Placement screenings are conducted for a number of different reasons. Staff began recording the reason for conducting placement screenings in April 2017, though it was infrequently recorded during the first year of data collection (as indicated by the red dotted line in the chart below). In Q3 2018, the reason listed for screening was "probation violation" for 15 (35%), "new charge" for 16 (37%), "needs-based" for 3 (7%), "investigation" for 8 (19%), and missing data for 1 (2%).





### Placement screening type by race (detail)

Staff began recording parental attendance at placement screenings in April 2018. In Q3 2018, parents were in attendance at 60% (N=26) of placement screenings, up from 48% in Q2 2018. To increase parent participation, parents were given the opportunity to attend via phone in Q3 2018. The chart below shows parental attendance by client race.

## About this Report

The Department of Community Corrections and Rehabilitation has been tracking Correctional Outof-Home Placements (COHP) for juvenile offenders since 2009. This report describes youth who were in out of home placement during the third quarter of 2018.

This report provides a breakdown of the youth in open and closed placements. Placements open on the last day of the quarter (i.e., September 30, 2018) are broken out by race and gender. Average length of stay is broken out by race and reported for closed placements. Placement Type is classified in several ways. Overall, placements are organized by Hennepin County (HC), Greater Minnesota (MN), and Out of State (OS). Within those categories, placements are broken out by Residential Treatment Center (RTC) placements, Sex Offender (SO) placements, County Home School (CHS- HC only) placements, and other placements of the placement screening types are similarly broken out by RTC placements, Sex Offender placements and other placements. Data is pulled 45 days after each quarter ends from the juvenile case management information system (MAIn) using the COHP Population Report.
