Out-of-Home Placement & Screening Trends: Q2 2019

About this Report

The Department of Community Corrections and Rehabilitation (DOCCR) has been tracking Correctional Out-of-Home Placements (COHP) for juvenile offenders since 2009. This report describes youth who were in out-of-home placement during the second quarter of 2019. Data is pulled from the juvenile case management information system (MAIn) using the COHP Population Report 45 days after each quarter ends.

This report provides trend data on youth with placements that closed during the quarter, as well as those with placements that were open

on the last day of the quarter (June 30, 2019). Placements are organized by location (Hennepin County, Greater Minnesota, or out of state), and by type (residential treatment centers, sex offender treatment centers, the County Home School, or other placements). Other placements include foster homes, shelters, transition centers, group homes, chemical dependency centers, mental health centers, and evaluations. This report also organizes placements by race and gender.

The DOCCR has been tracking data on COHP screenings since 2013. This report provides data on placement screenings by type, location, reason, race, and parental involvement.



Total Out-of-Home Placements

Figure 1¹ shows the breakout of Hennepin County clients in out-of-home placements. Overall, there were 172 out-of-home placements in quarter two of 2019. Thirty-one percent were placements within Hennepin County, 59% were placements in Greater Minnesota, and 10% were out of state placements.





¹ Numbers represent number of out-of-home placements, not number of youth. Youth may have more than one placement within the reporting period.


Out-of-Home Placement & Screening Trends 2

Closed Placements

Figure 2² shows the breakout of closed out-of-home placements (those which ended in the quarter). Of the 172 total placements, 69 closed during quarter two of 2019.

Thirty-five percent of the placements that closed were placements in Hennepin County, 58% were Greater Minnesota placements and 7% were out of state placements.



Out-of-Home Placement & Screening Trends 3

The average length of stay (average number of days in placement) for youth with placements that closed during quarter two of 2019 is shown below. The average length of stay for youth of color (n=64) was 202 days. The length of stay for white youth (n=5) was 119 days.





*In Q4 2017, median LOS is reported for white placements to account for artificial inflation due an outlier with a LOS of 1063 days. *In Q1 2018, median LOS is reported for of color placements to account for artificial inflation due to two outliers with a LOS above 900.


Open Placements

There were 103 youth in an out-of-home placement on the last day of the quarter (June 30, 2019).

Twenty-six percent of open placements were in Hennepin County, 60% were in Greater Minnesota, and 12% were out of state (see Figure 5).

A majority of open placements (55%) in Hennepin County were at the County Home School (CHS). Just under 7 in 10 (66%) placements in Greater Minnesota were in a residential treatment center (RTC), as were all (100%) placements outside of Minnesota.

The chart below shows the number of male and female youth in out-of-home placement on the last day of the quarter (June 30, 2019).





Figure 6. Open placements by gender








Figure 8. Girls in open placements by race

Placement Screening

Youth receive a placement screening to determine if an out-of-home placement is recommended³. The chart below shows the number of placement screenings conducted on youth by quarter. There was a 55% decrease in screenings between Q2 2014 and Q2 2019.




Figure 12. Number of placement screenings

Placement screenings are conducted for a number of different reasons⁴. In Q2 2019, 14 screenings (26%) were conducted because of a probation violation, 29 (55%) for a new charge, 2 (4%) were needs-based, and 3 (6%) were for an investigation.





Figure 13. Reason for placement screening

³ At times a youth may be screened for more than one placement on a single day. These records have been counted as duplicates and have been removed for analysis. Youth who are sent directly to placement as a court order have also been removed for analysis.

⁴ Staff began recording the reason for conducting placement screenings in Q2 2017, though it was infrequently recorded until Q2 2018.

The following chart shows the type of placement recommended by the screening committee. Here, the "Other" category includes foster homes, group homes, shelters, transition, chemical dependency, mental health and evaluation. In some cases, the screening committee recommends a community-based service, indicated as "No OHP Specified (Community)".





The following chart and table show the breakdown of placement screenings by race. About half (52%) of the screenings completed for youth of color were for RTC/Short Term placements.




Figure 15. Placement screenings by race

Staff began recording parental attendance at placement screenings in Q2 2018. To increase parent participation, parents were given the opportunity to attend via phone, beginning in Q3 2018. In Q2 2019, parents were in attendance at 57% (N=30) of placement screenings, up from 48% in Q1 2019 and 56% in Q4 2018.




Figure 17. Q2 2019 Parental attendance at placement screening by client race
