## Out-of-Home Placement & Screening Trends: Q3 2019

### About this Report

The Department of Community Corrections and Rehabilitation (DOCCR) has been tracking out-of-home placements (OHP) for juvenile offenders since 2009. This report describes youth who were in out-of-home placement during the 3rd quarter of 2019. Data is pulled from the juvenile case management information system (MAIn) using the OHP Population Report.

This report provides trend data on youth with placements that closed during the quarter, as well as those with placements that were open on the last day of the quarter (September 30, 2019). Placements are organized by location (Hennepin County, Greater Minnesota, or out of state), and by type (residential treatment centers, sexual health treatment centers, the County Home School, foster homes, shelters, transition centers, group homes, chemical dependency centers, mental health centers, and evaluations). This report also organizes placements by race and gender.

The DOCCR has been tracking information about the screening process for out-of-home placements since 2013. This report provides data on placement screenings by type, location, reason, race, and parental involvement.

#### Highlights/Key Trends:

- Screenings
  - o The number of placement screenings has continued to trend downward
  - More than half of the screenings were done for a new charge
  - o Almost <sup>3</sup>/<sub>4</sub> of youth screen identified as Black/African American
  - o In Q3 2019, parents attended less than half of the screenings; this is down from Q2 2019
- Placements
  - Youth whose placement ended in Q3 2019, spent a median of 156 days (5 months) in placement
  - Two-thirds of youth with an open placement during Q3 2019 were placed outside of Hennepin County
  - Youth of color are the majority of youth in placement



#### Total Out-of-Home Placements

Figure 1<sup>1</sup> shows the breakout of Hennepin County clients in out-of-home placements. Overall, there were 141 out-of-home placements in quarter three of 2019. Thirty-three percent were placements within Hennepin County, 55% were placements in Greater Minnesota, and 12% were out of state placements.

Figure 1. Total Out-of-Home Placements Q3 2019





#### Closed Placements

Figure 2<sup>2</sup> shows the breakout of closed out-of-home placements (those which ended in the quarter). Of the 141 total placements, 53 closed during quarter three of 2019.

Thirty-six percent of the placements that closed were placements in Hennepin County, 49% were Greater Minnesota placements and 15% were out of state placements.

Excluding youth in Sexual Health Treatment, the median number of days in placement for youth with placements that closed during quarter 3 of 2019 is shown below. The median number of days in placement for youth of color (n = 44) was 156 days. The median length of stay for white youth (n = 4) was 223 days. Five youth of color closed on Sexual Health Treatment in Q3 2019 and the median time in place was 243 days. Figures 3 and 4 show the median number of days in placement for placements that closed in that quarter excluding Sexual Health Treatment.



## Open Placements

There were 88 youth in an out-of-home placement on the last day of the quarter (September 30, 2019).

Thirty one percent of open placements were in Hennepin County, 59% were in Greater Minnesota, and 10% were out of state (see Figure 5)<sup>3</sup>.

Figure 6. Open placements by gender





Figure 7. Boys in open placements by race






Figure 8. Girls in open placements by race

## Placement Screening

Youth receive a placement screening to determine if an out-of-home placement is recommended<sup>4</sup>. The chart below shows the number of placement screenings conducted on youth by quarter. There was a

<sup>&</sup>lt;sup>4</sup> At times a youth may be screened for more than one placement on a single day. These records have been counted as duplicates and have been removed for analysis. Youth who are sent directly to placement as a court order have also been removed for analysis, though the trend appears in Figure 12.

75% decrease in initial screenings between Q2 2014 and Q3 2019. After six months, placements may be re-screened for a 90 day extension.

Placement screenings are conducted for several different reasons<sup>5</sup>. In Q3 2019, 10 screenings (24%) were conducted because of a probation violation, 22 (54%) for a new charge, 5 (12%) were needsbased, and 4 (10%) were for an investigation.




Figure 13. Reason for placement screening

Probation Violation: Client is being screened due to probation violations other than a new offense.

<sup>&</sup>lt;sup>5</sup> Staff began recording the reason for conducting placement screenings in Q2 2017, though it was infrequently recorded until Q2 2018. **Investigation**: Client is pending an Investigation event and is not already on probation; **Needs**: Client's placement is needs-based (housing need, closure of past placement, etc.); **New Charge**: Client both a new offense AND probation violation;

The following chart and table show the breakdown of placement screenings by race. Of the 41 screenings, 30 (73%) were youth who identified as Black/African American.

Figure 14. Placement screenings by race




Figure 15. Placement screenings by type and race

Staff began recording parental attendance at placement screenings in Q2 2018. To increase parent participation, parents were given the opportunity to attend via phone, beginning in Q3 2018. In Q3 2019 parents were in attendance at 49% (N=20) of placement screenings.
