### I. Updates

Katie Walker opened the meeting and introduced Mark Fuhrmann, Director of New Starts Rail Project. Members introduced themselves and provided updates. Vicki Moore updated the group on the Harrison neighborhood. Vida Ditter discussed the SW LRT station as an anchor to development at "The Meadows". Barry Schade discussed B.M. construction and Denny Spalla indicated that the company has lots of property in Minnetonka and Eden Prairie which will be on the edge of City West. Jeanette Colby shared that neighbors are very concerned about impacts on parks, homes, and the neighborhood. Ms. Colby stated that discussion has taken place about whether there should be a station or not and planners have done a great job in that the minimal station fits with the neighborhood. Bill James shared that he represents three stations in St. Louis Park and that the freight rail reroute issue is a big issue for his village. Art Higinbotham stated that he attended an excellent Station Area Planning meeting the evening before. Mr. Higinbotham shared that concerns exist over W. Lake and 21st Street Stations and the mitigation there. Mr. Higinbotham also shared that he appreciates St. Louis Park's concerns in light of the derailment in October. Rick Weiblen stated that he has been keeping tenants of Liberty Property Trust in the Golden Triangle updated. Frank Powell, as a former city council member, discussed the termination terminal and traffic in Eden Prairie.

#### II. Project Update

Katie Walker (Hennepin County) stated that the DEIS document will be released in the future and at that point, CAC members will be able to comment on the document and assist their neighbors and organizations in commenting and spreading the word about public hearings and informational meetings.
