### DEIS: Locally Preferred Alternative (LPA) Evaluation Process Progressing

The DEIS consultants continue to assemble information and technical analyses to inform a recommendation on the LPA. Each alternative, LRT 1A, 3A, 3C, and 3C sub-alternative, will be evaluated on the following criteria:

- Compatibility with existing municipal, county-level, and regional planning documents
- Performance (ridership, costs, cost-effectiveness, transit system integration, etc...)
- Potential Impact to Critical Environmental Resources
- Other Factors (acquisition/displacements, transportation system impact, constructability)

### Transit Projects Receive \$21 million in 2009 Minnesota Bonding Bill

The 2009 State Bonding bill included \$21 million for transit projects with \$8.5 million identified for Central Corridor LRT. The Metropolitan Council will allocate the remaining \$12.5 million amongst the following eligible projects: Bottineau Transitway, Cedar Lake Bus Rapid Transit (BRT), Red Rock Corridor, Riverview Corridor, Robert Street BRT, Rush Line Corridor, Southwest Transitway, and the St. Paul Union Depot.

### **Station Area Planning Progressing**

# Southwest Policy Advisory Committee (PAC)
